PLAN OF MERGER

- Constituent Corporations The parties to this merger are TGI FRIDAY'S INC., a New York corporation originally formed under the name "T G I Friday's Inc." ("Parent"), and TGI Friday's of Minnesota, Inc., a Minnesota corporation originally formed under the name "T G I Thursday's Inc." ("Subsidiary"). Parent and Subsidiary are referred to together as the "Constituent Corporations" and sometimes individually as a "Constituent Corporation."
- Outstanding Shares of Subsidiary Parent is the sole shareholder of Subsidiary 2.) and owns one hundred (100) shares of common stock of Subsidiary, representing one hundred percent (100%) of the issued and outstanding shares of Subsidiary.
- The Merger On the Effective Date (as defined in Section 4 of this Plan of Merger), each of the Constituent Corporations shall be merged together (the "Merger"), with Parent being the surviving corporation (Parent as the surviving corporation is hereinafter referred to as the "Surviving Corporation"), and the separate corporate existence of Subsidiary shall cease. The Surviving Corporation shall become the owner, without transfer except as provided by applicable law, of all the rights and properties of the Constituent Corporations, and the Surviving Corporation shall become subject to all the debts and liabilities of the Constituent Corporations in the same manner as if the Surviving Corporation had itself incurred them.
