## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, for itself and on behalf of the Lenders, hereby unconditionally and expressly releases, terminates, and extinguishes any and all liens and security interests, and any and all right, title and interest it, or the Lenders, has or may have upon all of each Company’s Trademark Collateral, as defined in the agreements listed below (collectively, the “Trademark Security Agreements”):

(iv) that certain Amended and Restated Trademark Security Agreement, dated as of September 17, 2013, made by each of Animal Supply, Retail Independence, Retail Success Services, LLC and Loan Star in favor of Collateral Agent, recorded with the USPTO on September 26, 2013 at Reel 5118, Frame 0392;

(v) that certain Trademark Security Agreement, dated as of September 20, 2013, made by RFG in favor of Collateral Agent, recorded with the USPTO on September 26, 2013 at Reel 5118, Frame 0377;

(vi) that certain Trademark Security Agreement, dated as of March 30, 2015, made by Animal Supply in favor of Collateral Agent, recorded with the USPTO on April 6, 2015 at Reel 5492, Frame 0924;

(vii) that certain Trademark Security Agreement, dated as of November 13, 2015, made by Animal Supply in favor of Collateral Agent, recorded with the USPTO on November 19, 2015 at Reel 5672, Frame 0478; and

(viii) that certain Trademark Security Agreement, dated as of January 12, 2016, made by Animal Supply in favor of Collateral Agent, recorded with the USPTO on January 28, 2016 at Reel 5718, Frame 0086;





