**ASSIGNMENT OF TRADEMARK SECURITY INTEREST**

ASSIGNMENT OF TRADEMARK SECURITY INTEREST, dated as of March 20, 2017 (this "Assignment"), by MORGAN STANLEY SENIOR FUNDING, INC., as the resigning administrative agent and resigning collateral agent (in such capacity, "Assignor"), in favor of CORTLAND PRODUCTS CORP., as the successor administrative agent (in such capacity, "Assignee").

**WITNESSETH:**

WHEREAS, Assignor is party to that certain First Lien Security Agreement, dated as of March 11, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Payless, Inc. and the other Grantors (as defined therein) party thereto (collectively, the "Grantors"), in favor of the Assignor;

WHEREAS, pursuant to (i) the Security Agreement and (ii) that certain Grant of First Lien Security Interest in United States Trademarks dated as of March 11, 2014 and recorded with the United States Patent and Trademark Office ("USPTO") on March 20, 2014 at Reel 5240 and Frame 0872 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Grant"), by Grantors in favor of the Assignor, each of the undersigned Grantors has granted to Assignor a first lien security interest in, and lien on, all of its right, title and interest in and to (i) all of the Grantors' right, title and interest in, to and under to the United States trademarks, trademark registrations and trademark applications (except any intent-to-use applications for trademark registrations for which a statement of use has not yet been filed) set forth on Schedule I annexed hereto (the "Marks"), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, (iv) all income, fees, royalties, damages, claims and payments now or hereafter due and/or payable thereunder and with respect thereto including, without limitation, damages and payments for past, present or future infringements thereof, (v) any and all rights corresponding thereto throughout the world, and (vi) any and all rights to sue for past, present or future infringements thereof ((i)-(vi), collectively, the "Trademark Collateral");

WHEREAS, effective as of March 20, 2017, Assignor resigned as administrative agent and collateral agent under the Credit Agreement (as defined in the Security Agreement) and the other Loan Documents (as defined in the Credit Agreement);

WHEREAS, pursuant to that certain First Lien Agency Resignation and Appointment Agreement and First Amendment Agreement to Credit Agreement, dated as of March 20, 2017, among Assignor, Assignee, the Loan Parties (as defined in the Credit Agreement), and the Lenders (as defined in the Credit Agreement) party thereto, Assignee has assumed and succeeded to all of the rights, powers, discretions, privileges and duties of Assignor as administrative agent under the Credit Agreement and the other Loan Documents; and

WHEREAS, Assignor and Assignee desire to enter into this Assignment to evidence the assignment by Assignor to Assignee of all of Assignor's right, title and interest in and to Assignor's security interest in, and lien on, the Trademark Collateral, pursuant to the Security Agreement and the Grant.

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or the Credit Agreement, as applicable.

2. ASSIGNMENT. Assignor does hereby transfer, assign, grant and convey to Assignee all of its right, title and interest in and to Assignor's security interest in, and lien on, the Trademark Collateral pursuant to the Security Agreement and the Grant, and Assignee does hereby accept and assume all of such right, title, interest, security interest and lien.

3. FURTHER ASSURANCES. Assignor hereby agrees, at the sole expense of the Borrowing Agent, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to fully effectuate and record this Assignment and to consummate the transactions contemplated hereby.

4. ACKNOWLEDGMENT OF GRANTORS. Each Grantor hereby (i) confirms its grant to Assignee of a security interest in, and lien on, the Trademark Collateral to secure the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations and (ii) acknowledges and affirms that the rights and remedies of Assignee with respect to its security interest in, and lien on, the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

5. RECORDATION. Assignor hereby authorizes the Commissioner for Trademarks of the USPTO and any other applicable government officer to record this Assignment.

6. GOVERNING LAW. This Assignment shall be governed by and construed in accordance with the laws of the State of New York.

7. COUNTERPARTS. This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.
