TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement") is by and between **Cummins Pacific, LLC**, a California limited liability company, having an address at 1939 Deere Avenue, Irvine, California 92606 ("Assignor"), and **Cummins Inc.**, an Indiana corporation, having an address at 500 Jackson Street, Columbus, Indiana 47201 ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Trademark, together with all goodwill associated with said Trademark, and the right to sue and recover for, and the right to profits or damages due or accrued, arising out of or in connection with any and all past, present or future infringements or dilution of or damage to the Trademark or the associated goodwill.

Assignor further agrees that, without further consideration, it will cause to be performed such other lawful acts, and to be executed such further assignments and other lawful documents, as Assignee may, from time to time, reasonably request to effect fully this Agreement and to permit Assignee to be duly recorded as the registered owner of the Trademark in the United States. Assignor agrees to cooperate fully with Assignee to accomplish such recordation.

This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute a single instrument.

This Agreement shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors and assigns.
