**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the "Release") is made effective as of March 31, 2017, by Danske Bank A/S, for itself and for and on behalf of the other Secured Parties (in such capacity, the "Agent"), to Navico, Inc. a Delaware corporation (the "Grantor"). All capitalized terms not defined herein shall have the respective meaning given to them in the USD 265,000,000 facilities agreement originally dated 11 July 2016 (as amended by amendment requests dated 24 August 2016 and 27 September 2016 and as further amended and/or restated from time to time) between, inter alios, Nanna MidCo II AS (formerly Athomstart Invest 89 AS) as Parent, Navico Group AS (formerly Nanna BidCo AS and Athomstart Invest 90 AS) as Company, Coöperatieve Rabobank U.A., Danske Bank A/S, DNB Bank ASA, ING Bank N.V. and Nordea Bank Norge ASA as Arrangers, certain financial institutions listed therein as Original Lenders and Danske Bank A/S as Agent and Security Agent (each as defined therein) (the "Existing Facilities Agreement").

WHEREAS, Grantor owns the trademarks listed on Schedule A attached hereto (the "Trademarks"), which Trademarks are pending or registered with the United States Patent and Trademark Office;

WHEREAS, pursuant to that certain (i) pledge and security agreement, dated as of 30 September 2016 by and among Nanna U.S. BidCo LLC and the Grantor as grantors and the Agent as security agent and (ii) trademark security agreement, dated as of 30 September 2016 (the "Trademark Security Agreement"), by and among the Grantor as grantor and the Agent as security agent, a lien on and security interest in certain Trademark Collateral (as hereinafter defined) (the "Security Interest") was granted by the Grantor to the Agent. The term "Trademark Collateral" means (1) all of the Grantor's right, title and interest in and to the Trademarks then owned or from time to time after the date thereof owned or acquired by Grantor, together with (2) all written agreements providing for the granting of any right in or to any Trademark to which Grantor is a party, (3) all reissues, continuations or extensions of the foregoing, (4) all proceeds of the foregoing, (5) the goodwill associated with such Trademarks and (6) all causes of action arising prior to or after the date thereof for infringement of such Trademarks or unfair competition regarding the same, including, without limitation, the Trademarks listed on the attached Schedule A;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent & Trademark Office on September 30, 2016 at Reel/Frame 5896/0955; and

WHEREAS, the Agent wishes to release its Security Interest in the Trademark Collateral.




