**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL LETTER**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL LETTER (this "Release Letter") is made as of April 6, 2017 (the "Effective Date"), by Deutsche Bank Trust Company Americas ("DBTCA"), in its capacity as collateral agent under the Security Documentation (as defined herein) (in such capacity, the "Collateral Agent"), in favor of each of Dole Food Company, Inc. ("Dole"), Bud Antle, Inc. ("Bud Antle"), Dole Fresh Fruit Company ("Dole Fresh Fruit"), Royal Packing LLC ("Royal Packing"), Dole Berry Company ("Dole Berry") and Dole Fresh Vegetables, Inc. ("Dole Fresh Vegetables" and, together with Dole, Bud Antle, Dole Fresh Fruit, Royal Packing and Dole Berry, "Grantors").

WHEREAS, reference is made to that certain Indenture dated as of November 1, 2013 (the "Indenture") among DFC Holdings, LLC, Dole, as issuer (the "Issuer") the other guarantors party thereto and DBTCA, as trustee (the "Trustee"), registrar, paying agent and Collateral Agent.

WHEREAS, in connection with the Indenture, Grantors and the Collateral Agent entered into that certain (i) Security Agreement dated as of November 1, 2013 (as amended, restated or otherwise modified from time to time, the "Security Agreement"), (ii) Patent Security Agreement, dated as of November 1, 2013 (the "Patent Security Agreement"), by Dole and Dole Fresh Vegetables, in favor of the Collateral Agent, (iii) Trademark Security Agreement, dated as of November 1, 2013 (the "Trademark Security Agreement"), by the Grantors in favor of the Collateral Agent and (iv) Copyright Security Agreement, dated as of November 1, 2013 (the "Copyright Security Agreement" and together with the Patent Security Agreement and the Trademark Security Agreement, the "Security Documentation"), by Dole, in favor of the Collateral Agent;

WHEREAS, pursuant to the Security Agreement and the Security Documentation, the Grantors granted to the Collateral Agent Liens in certain collateral, including (i) the trademarks listed on Schedule 1 attached hereto (the "Trademark Collateral"), which was recorded with the United States Patent and Trademark Office at reel 5148, frame 0648, (ii) the patents listed on Schedule 2 attached hereto (the "Patent Collateral"), which was recorded with the United States Patent and Trademark Office at reel 031597, frame 0857, and (iii) the copyrights listed on Schedule 3 attached hereto (the "Copyright Collateral" and together with the Trademark Collateral and the Patent Collateral the "IP Collateral"), which was recorded with the United States Copyright Office at volume 3620 document 314;

WHEREAS, pursuant to Section 8.13 of the Security Agreement, (i) the Security Agreement shall terminate on the date (the "Termination Date") upon which there has been a Discharge of Obligations with respect to the Indenture and each Additional Pari Passu Agreement and (ii) the Grantors may reasonably request the Collateral Agent to acknowledge the satisfaction and termination of the Security Agreement (the "Satisfaction and Termination");

WHEREAS, pursuant to Section 4 of the Security Documentation, the Grantors may request a written instrument from the Collateral Agent acknowledging the release (the "Release" and together with the Satisfaction and Termination, the "Release and Termination") of the IP Collateral;

WHEREAS, in connection with the Release and Termination, the Grantors (i) desire the Collateral Agent to acknowledge the Release and Termination and (ii) have delivered to the Collateral Agent a certificate (the "Officers' Certificate") signed by an officer of the Grantors stating that the conditions precedent to the Release and Termination have been satisfied and the Release and Termination is authorized and permitted pursuant to the Security Agreement and the Security Documentation (including,

but not limited to, Section 8.03(a) of the Security Agreement and Section 4 in each of the Security Documentation), upon which the Collateral Agent may conclusively rely;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby covenants and agrees as follows:


1. All capitalized terms used, but not otherwise defined herein, shall have the meanings set forth in the Indenture, Security Documentation or the Security Agreement, as applicable.
2. In reliance on the the certifications contained in the Officers' Certificate, the Collateral Agent hereby terminates, discharges and releases all Liens in the IP Collateral.
3. To the extent the Collateral Agent acquired any other interest in the IP Collateral, the Collateral Agent hereby assigns, transfers and conveys to each applicable Grantor, all of the Collateral Agent's right, title and interest that it may have, whether by assignment or otherwise, in and to the IP Collateral.
4. The Collateral Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested in writing and prepared by the Grantors in order to more fully and effectively carry out the purposes of this Release Letter at the Grantor's sole cost and expense.
