TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is effective as of February 3, 2017 (the "Effective Date"), by and between Hospira, Inc., a Delaware corporation ("Assignor") and ICU Medical, Inc., a Delaware corporation ("Assignee"). Assignor and Assignee are sometimes referred to herein individually as a "Party" and collectively as the "Parties." Capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Purchase Agreement (as defined herein).

RECITALS:

WHEREAS, Pfizer Inc., a Delaware Corporation ("Seller Parent") and Assignee are parties to that certain Amended and Restated Stock and Asset Purchase Agreement, dated as of January 5, 2017 (amending and restating that certain Stock and Asset Purchase Agreement dated as of October 6, 2016 between Seller Parent and ICU, and as may be further amended from time to time, the "Purchase Agreement"); and

WHEREAS, pursuant to the Purchase Agreement, Seller Parent sold, conveyed, assigned and transferred to Assignee all of Seller Parent's right, title and interest in and to the Business Trademark Rights, including the trademark registrations, trademark applications and domain name registrations identified on Schedule A, but excluding all Retained Names (collectively, the "Assigned Trademarks"), subject to the terms and conditions of the Purchase Agreement;

WHEREAS, pursuant to the Purchase Agreement, Seller Parent and Assignee have agreed to execute this Assignment; and

WHEREAS, Assignor, a wholly-owned subsidiary of Seller Parent, is the owner of the Assigned Trademarks as of the Effective Date.

NOW, THEREFORE, in consideration of the foregoing, and including the consideration set forth in the Purchase Agreement, the representations, warranties, covenants and agreements contained herein, and other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, the Parties hereby agree as follows:

1. **Conveyance.** Assignor hereby sells, assigns, transfers, and conveys to Assignee, and Assignee hereby accepts, Assignor's entire right, title and interest at Closing in, to and under (a) the Assigned Trademarks, together with the goodwill symbolized thereby, and, with regard to any Assigned Trademarks that are intent to use applications, the Parties acknowledge that the portion of Assignor's and its Affiliates' business in respect of which Assignor and its Affiliates' have a bona fide intent to use such marks is also being transferred pursuant and subject to the Purchase Agreement, and (b) all rights accruing under, and causes of action and other remedies with respect to, the Assigned Trademarks, including the right to sue for and to recover damages and other remedies in respect of any past, present or future infringement or other unauthorized use of the Assigned Trademarks.


2. **Issuance and Recordation.** Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any foreign country whose duty it is to issue trademarks on applications as described above, to issue any and all Assigned Trademarks to Assignee, its successors and assigns. Assignor hereby requests the Commissioner of Patents and Trademarks of the United States, and the corresponding entities or agencies in any applicable foreign jurisdiction, to record Assignee as the purchaser and owner of the Assigned Trademarks. Assignee shall have the right to record this Assignment with all applicable governmental authorities and registrars so as to perfect its ownership of the Assigned Trademarks.
3. **No Modification.** The Parties acknowledge and agree that this Assignment is entered into pursuant to the Purchase Agreement, and nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend or otherwise change any of the rights or obligations of Assignee or Seller Parent under the Purchase Agreement, and, in the event and to the extent that there is a conflict between the provisions of this Assignment and the provisions of the Purchase Agreement, the Purchase Agreement shall control.
4. **Successors and Assigns.** This Assignment shall inure to the benefit of and be binding upon the Parties and their respective successors and permitted assigns.
5. **Counterparts.** This Assignment may be executed in counterparts (including by facsimile or electronic .pdf submission), each of which shall be deemed an original, and all of which shall constitute one and the same agreement and shall become effective when one or more counterparts have been signed by each of the Parties and delivered (by telecopy or otherwise) to the other Party, it being understood that both Parties need not sign the same counterpart.
6. **Interpretation.** The heading references herein are for convenience purposes only, do not constitute a part of this Assignment and shall not be deemed to limit or affect any of the provisions hereof.
7. **Further Assurances.** Upon Assignee's request and at Assignee's expense, Assignor agrees to provide reasonable cooperation and assistance as is reasonably required by Assignee to effect and register the rights assigned herein (including to execute, acknowledge, and deliver such other documents and take such other actions as may be reasonably required), and, in general, provide reasonable lawful cooperation reasonably requested by Assignee to carry out and fulfill the purposes and intent of this Assignment of the Assigned Trademarks, in each case, in accordance with and subject to the Purchase Agreement.
8. **Governing Law; Jurisdiction.** This Assignment shall be governed by and construed in accordance with the laws of the State of New York, without regard to the conflicts of law rules of such state. With respect to any suit, action or proceeding relating to this Assignment (each, a "Proceeding"), each Party irrevocably (i) agrees and consents to be subject to the jurisdiction of the United States District Court for the Southern District of New York or, if for any reason the United States District Court for the Southern District of New York lacks subject matter jurisdiction, any New York State court sitting in New York City and (ii) waives any objection which it may have at any time to the laying of venue of any Proceeding brought in any such court, waives any claim that such Proceeding has been brought in an inconvenient forum and further waives the right to object, with respect to such Proceeding, that such court does not have any jurisdiction over such Party. THE PARTIES HEREBY AGREE THAT

MAILING OF PROCESS OR OTHER PAPERS IN CONNECTION WITH ANY SUCH ACTION OR PROCEEDING IN THE MANNER PROVIDED IN SECTION 10.1 OF THE PURCHASE AGREEMENT, OR IN SUCH OTHER MANNER AS MAY BE PERMITTED BY LAW, SHALL BE VALID AND SUFFICIENT SERVICE THEREOF AND HEREBY WAIVE ANY OBJECTIONS TO SERVICE ACCOMPLISHED IN THE MANNER HEREIN PROVIDED.




