TRADEMARK SECURITY AGREEMENT, dated as of April 5, 2017 (this "<u>Agreement</u>"), among the Grantors listed on the signature pages below (each, a "<u>Grantor</u>") and JPMorgan Chase Bank, N.A., as administrative agent (the "<u>Administrative Agent</u>").

Reference is made to (a) the Credit Agreement, dated as of June 17, 2016, among Gartner, Inc. (the "Borrower"), the several banks and other financial institutions or entities from time to time parties thereto (the "Lenders"), the Co-Syndication Agents, the Co-Documentation Agents and the Administrative Agent, as amended by the First Amendment, dates as of January 20, 2017, among the Borrower, each other Loan Party party thereto, the Lenders party thereto and the Administrative Agent, as further amended by the Second Amendment, dated as of March 20, 2017, among the Borrower, each other Loan Party party thereto, the Lenders party thereto and the Administrative Agent (as further amended, supplemented or otherwise modified from time to time, the "Credit Agreement"); (b) the Guarantee and Collateral Agreement, dated as of June 17, 2016 (as amended, supplemented and restated or replaced from time to time, the "Collateral Agreement"), among the Borrower, certain of its Subsidiaries and the Administrative Agent; and (c) the Assumption Agreement, dated as of April 5, 2017 (the "Assumption Agreement"), made by CEB Inc. (f/k/a The Corporate Executive Board Company) ("CEB"), CXO Acquisition Co. and Evanta Ventures, Inc. ("Evanta"), in favor of the Administrative Agent.

Pursuant to the Credit Agreement, the Lenders and the Issuing Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein. The obligations of the Lenders to extend such credit are conditioned upon, among other things, the execution and delivery of this Agreement. The Borrower is a member of an affiliated group of companies that includes each other Grantor. The Borrower and the other Grantors are engaged in related businesses, and each Grantor will derive substantial direct and indirect benefit from the making of the extensions of credit under the Credit Agreement and is willing to execute and deliver this Agreement in order to induce the Lenders to make their respective extensions of credit to the Borrower under the Credit Agreement. Pursuant to the Assumption Agreement, CEB and Evanta each becomes a party to the Collateral Agreement as a Grantor thereunder with the same force and effect as if originally named therein as a Grantor and has expressly assumed all obligations and liabilities of a Grantor thereunder.

Accordingly, the parties hereto agree as follows:

SECTION 1. <u>Terms.</u> Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreement or the Collateral Agreement, as applicable.

SECTION 2. Grant of Security Interest. As collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of such Grantor's Obligations, each Grantor hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in, to and under the United States trademark registrations and applications for registration listed on Schedule A attached hereto (the "Trademark Collateral"). This Agreement is not to be construed as an assignment of any Trademark. Notwithstanding anything herein to the contrary, the Trademark Collateral shall not include, and in no event shall any security interest attach to, any intent-to-use trademark applications filed in the United States Patent and Trademark Office, pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. Section 1051, prior to the accepted filing of a "Statement of Use" and issuance of a "Certificate of Registration" pursuant to Section 1(d) of the Lanham Act or an accepted filing of an "Amendment to Allege Use" whereby such intent-to-use trademark application is converted to a "use in commerce" application pursuant to Section 1(c) of the Lanham Act.

SECTION 3. <u>Collateral Agreement.</u> The security interests granted to the Administrative Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the

Administrative Agent pursuant to the Collateral Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the Trademark Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall govern.

SECTION 4. <u>Counterparts.</u> This Agreement may be executed by one or more of the parties to this Agreement on any number of separate counterparts (including by email or telecopy), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.

SECTION 5. <u>Governing Law</u>. This Agreement shall be governed by, and construed and interpreted in accordance with, the law of the state of New York.
