NUNC PRO TUNC TRADEMARK ASSIGNMENT

This NUNC PRO TUNC TRADEMARK ASSIGNMENT (“*Assignment*”) is entered into as of 22 February, 2017, by PENTAIR INTERNATIONAL HOLDING S.A.R.L., a limited liability company organized and existing under the laws of Luxembourg, having an address at 26, Boulevard Royal, L-2449 Luxembourg (“*Assignor*”), in favor of PENTAIR FLOW SERVICES AG, a limited liability company organized and existing under the laws of Switzerland, having an address at Freier Platz 10, CH-8200 Schaffhausen Switzerland (“*Assignee*”).

WHEREAS, Assignor owns all right, title and interest in and to the trademark registrations and applications for registration, identified and set forth on Schedule A attached hereto, and all goodwill associated therewith (the “*Marks*”);

WHEREAS, pursuant to that certain Contribution and Transfer Agreement between the parties dated as of 01 October 2012 (the “*Agreement*”), Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all right, title and interest in and to the Marks and all goodwill associated with the Marks.


NOW, THEREFORE, for good and valuable consideration set out in the Agreement, the receipt, adequacy and sufficiency of which are hereby acknowledged, Assignor hereby agrees:



Effective as of 8 September 2015, Assignor hereby sells, contributes, transfers, grants, bargains, assigns and conveys to Assignee the entire right, title and interest in, to and under the Marks, together with the goodwill of the business associated therewith, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations and all corresponding rights that are or may be secured under applicable laws, now or hereafter arising or in effect, for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all rights to collect royalties, products and proceeds in connection with any of the foregoing and all rights to sue for past, present or future infringement, misappropriation, unfair competition, dilution or other violation of the foregoing, and all rights to recover damages or lost profits in connection therewith, and all rights corresponding thereto.
2. Assignor hereby requests The United States Patent and Trademark Office to record Assignee as the assignee and owner of the Marks and to deliver to Assignee, and to Assignee’s attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment.
3. Assignor shall provide Assignee, its successors and assigns, and their legal representatives such information, documents and assistance as Assignee or any such other person or entity may reasonably request (including, without limitation, execution and delivery of any affidavits, declarations, oaths or other documents as may reasonably be required) in connection with effectuating and implementing this Assignment.
