RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of the 13th day of April, 2017, by CIT BANK, N.A. (formerly known as OneWest Bank N.A., which was formerly known as OneWest Bank, FSB) in its capacity as Lender ("Secured Party") pursuant to the Security Agreement (as defined below), in favor of SOLID GOLD HOLDINGS, LLC, a Delaware limited liability company ("Holdings") and SOLID GOLD PET, LLC, a Delaware limited liability company (the "Company" and together with Holdings, "Grantors" and each a "Grantor").

W I T N E S S E T H

NOW THEREFORE, for good and valuable consideration previously tendered by Grantors, the receipt and sufficiency of which are hereby acknowledged:


1. Secured Party hereby releases its security interest in all of Grantors' right, title and interest in and to the Trademarks.
