**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of May 5, 2017 (this "Release"), is made by PNC Bank, National Association, as administrative agent (in such capacity, the "Agent"), in favor of (i) TopBuild Support Services, Inc., a Delaware corporation ("Support"), (ii) TruTeam, LLC, a Delaware limited liability company ("TruTeam"), (iii) Builder Services Group, Inc., a Florida corporation ("Builder"), (iv) Service Partners, LLC, a Virginia limited liability company ("Partners"), (v) Thermoguard Insulation Company, LLC, a Virginia limited liability company ("Thermoguard"), and (vi) Moore Products, LLC, a Virginia limited liability company ("Moore"), and together with Support, TruTeam, Builder, Partners and Thermoguard, collectively, the "Credit Parties") as follows:

**WITNESSETH**

WHEREAS, the Credit Parties, the Agent and the other parties thereto entered into that certain Pledge and Security Agreement on June 30, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, in connection with the Security Agreement, each Credit Party granted the Agent a security interest in certain collateral pledged by such Credit Party pursuant to the Trademark Security Agreement, dated September 13, 2016, which was recorded with the U.S. Patent and Trademark Office on September 14, 2016 at Reel/Frame No. 5876/0852 as further described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral"); and

WHEREAS, each Credit Party has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at Defender's sole cost and expense, hereby terminates, cancels and releases any security interest of the Agent in the Trademark Collateral and any all rights, title and interests of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.


