### RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

The Administrative Agent agrees, at the expense of the Credit Parties, to cooperate with the Credit Parties and to provide the Credit Parties with the information and additional authorization reasonably required to effect the release of the Administrative Agent's security interests in the Intellectual Property Collateral.
