**RELEASE OF
GRANT OF SECURITY INTEREST
IN TRADEMARKS**


WHEREAS, the Agent hereby wishes to release its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent for the benefit of the Secured Parties does hereby release and relinquish, and to the extent that the Agent for the benefit of the Secured Parties has acquired any right, title or interest in or to any of the Trademarks, does hereby reassign to the Grantors, without representation or warranty, all of the Agent's right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Grant in the United States Patent and Trademark Office as aforesaid may be removed of record.
