ASSIGNMENT OF TRADEMARK RIGHTS

This Assignment of Trademark Rights (this "<u>Agreement</u>") is made and entered into effective as of April 25, 2017, by and between Us Weekly LLC, a limited liability company organized under the laws of the State of Delaware with its principal place of business at 1290 Avenue of the Americas, New York, New York 10104 ("<u>Assignor</u>"), and American Media, Inc., a corporation organized under the laws of the State of Delaware with its principal place of business at 4 New York Plaza, New York, New York 10004 ("<u>Assignee</u>"). Assignor and Assignee shall each be a "<u>Party</u>", and collectively, the "<u>Parties</u>".

WHEREAS, Assignor and Assignee are each a party to that certain Asset Purchase Agreement dated as of March 15, 2017 (the "Purchase Agreement"), pursuant to which Assignee has agreed to acquire substantially all of the assets and rights of the Assignor necessary for the operation of, used in and related to the Business, including those associated with the Assigned Marks (as defined below);

WHEREAS Assignor is the owner of the trademark registrations and applications and common law trademarks set forth in **Exhibit 1** and incorporated herein by reference ("<u>Assigned Marks</u>"); and

WHEREAS, pursuant to the terms of the Purchase Agreement, Assignor has agreed to, among other things, transfer to Assignee the Assigned Marks, including the common law rights, registrations, applications and the goodwill associated therewith.

NOW, THEREFORE, in consideration of the representations, warranties, covenants and agreements set forth in the Purchase Agreement, the mutual promises of the Parties hereto and the mutual benefits to be gained by the performance hereof, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. <u>Assignment</u>. Assignor does hereby assign unto Assignee all right, title and interest in and to the Assigned Marks, together with, without limitation, all associated goodwill and common law rights appurtenant thereto, and all rights of action and remedies for past, present and future infringements of any of the Assigned Marks.
- 2. Recordation and Further Actions. Assignor authorizes the Commissioner for Trademarks and any other governmental officials to record and register this Agreement upon request by Assignee. The Assignor shall execute and deliver any and all instruments and documents and take such further actions as may be reasonably necessary or reasonably requested by the Assignee in writing, including the execution of any documents, files, registrations, or other similar items, in order to ensure that the Assigned Marks are properly assigned to Assignee and to document and record with the appropriate governmental authorities the aforesaid assignment and transfer.

- 3. Rights under Assignment; Conflicts. Each of Assignee and Assignor, by its execution of this Agreement, hereby acknowledges that the rights and remedies of each Party under the Purchase Agreement will not be deemed to be enlarged, modified or altered in any way by such execution and acceptance of this instrument. To the extent the terms and provisions of this Agreement conflict with the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern. All capitalized terms used but not defined herein shall have the meanings assigned to them in the Purchase Agreement.
- 4. <u>Successors and Assigns</u>. This Agreement and all of the provisions hereof shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and assigns.
- 5. <u>Governing Law</u>. This Agreement shall be governed in all respects, including validity, interpretation, and effect in the manner set forth in <u>Section 13.8</u> and <u>Section 13.9</u> of the Purchase Agreement.
- 6. <u>Counterparts</u>. This Agreement may be executed in two (2) or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
- 7. <u>Headings</u>. The paragraph headings contained in this Agreement are for reference purposes only and shall not in any way affect the meaning or interpretation of this Agreement.
