NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of May 15, 2017 is made by DEUTSCHE BANK TRUST COMPANY AMERICAS, in its capacity as collateral agent (referred to herein as the “Collateral Agent”), in favor of Wilton Industries, Inc. (the “Pledgor”), pursuant to that certain Security Agreement, dated as of August 30, 2012 (and as the same may be further amended or modified from time to time, the “Security Agreement”), among Wilton Brands, LLC, a Delaware limited liability company, the Pledgor, and other Subsidiaries of Wilton Brands, LLC and the Collateral Agent.

W I T N E S S E T H:

WHEREAS, in connection with the Security Agreement, the Pledgor executed and delivered the Trademark Security Agreement, dated as of August 30, 2012, in favor of the Collateral Agent (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, the Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and continuing security interest in all of their intellectual property, including but not limited to the trademarks, service marks and trademark and service mark registrations and applications of the Pledgor set forth on Schedule A attached hereto, together with the goodwill of the business symbolized thereby (the “Released Trademarks”);

WHEREAS, the Collateral Agent recorded its security interest in the Released Trademarks with the United States Patent and Trademark Office (the “USPTO”); and

WHEREAS, the Collateral Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent agrees, for the benefit of the Pledgor, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Term Loan Credit Agreement and Security Agreements, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Security Agreements).

SECTION 2. Release of Security Interest. The Collateral Agent does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, all of the Pledgor’s right, title and interest in, to and under the Released Trademarks.

SECTION 3. Termination. The Collateral Agent, without representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

SECTION 4. Filing. The Collateral Agent hereby authorizes the Pledgor or the Pledgor’s authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the



release of the security interest of the Collateral Agent in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.




