INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated as of March 8, 2017, is entered into by and between KCD IP, LLC, a Delaware limited liability company ("Assignor"), in favor of Sears Roebuck Acceptance Corp., a Delaware corporation ("Assignee"). Assignor and each Assignee are collectively the "Parties," and each a "Party."

WHEREAS, Assignor, Assignee and certain of their affiliates have entered into a Transaction Agreement, dated as of the date hereof (as amended, modified or supplemented from time to time in accordance with its terms, the "Transaction Agreement"), pursuant to which Assignor has agreed to sell, transfer, convey, assign and deliver to Assignee all of Assignor's right, title and interest in, to and under the trademark registrations and trademark applications set forth in Schedule 1 (the "Assigned Trademarks").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

SECTION 1. Definitions. Capitalized terms used but not defined herein have the meanings ascribed to such terms in the Purchase Agreement.

SECTION 2. Assignment. Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee, and Assignee hereby accepts the sale, transfer, conveyance, assignment and delivery of, all of Assignor's right, title and interest in, to and under the Assigned Trademarks together with all the goodwill associated with the use of or symbolized by the Assigned Trademarks; all rights of enforcement and the rights, interests, claims and demands recoverable in law or equity, that Assignor has or may have in profits and damages for past, present and future infringements, unfair competition, passing off or other conflicts relating to the Assigned Trademarks, including, without limitation, the right to compromise, sue for and collect such profits and damages; all rights of priority resulting from the filing of the Assigned Trademarks, and all other rights, including common law rights, relating to the Assigned Trademarks, to the extent such rights exist or may exist in the future, each to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives as said rights would have been held and enjoyed by such Assignor had this assignment and sale not been made; and

SECTION 3. Recordation. Each Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and other empowered officials of the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee.

SECTION 4. Further Assurances. At the request of Assignee, Assignor shall execute and deliver, or cause to be executed and delivered, such documents as the

Assignee or its counsel may reasonably request to further effectuate or evidence the transactions set forth in this Assignment.

SECTION 5. Subject to Purchase Agreement. This Assignment is being executed solely to give effect to the transactions contemplated by the Transaction Agreement. Nothing in this Assignment, express or implied, is intended to, or will be construed to, modify, expand or limit in any way the terms of the Transaction Agreement. To the extent that any provision of this Assignment conflicts or is inconsistent with the terms of the Transaction Agreement, the Transaction Agreement will govern.

SECTION 6. Counterparts. This Assignment may be executed in two or more counterparts, each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument, and shall become effective when one or more counterparts have been signed by each of the Parties and delivered (by telecopy, electronic delivery or otherwise) to the other Parties. Signatures to this Assignment transmitted by facsimile transmission, by electronic mail in "portable document format" (.pdf) form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, will have the same effect as physical delivery of the paper document bearing the original signature.

SECTION 7. Binding Effect. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and permitted assigns. This Assignment may not be assigned by any Party hereto without the prior written consent of the other Parties hereto.

SECTION 8. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of New York applicable to contracts executed and to be performed wholly within such State and without reference to the choice-of-law principles that would result in the application of the laws of a different jurisdiction.

SECTION 9. Consent to Exclusive Jurisdiction. Each party hereto irrevocably submits to the jurisdiction of any New York state or federal court in any action, suit, arbitration, litigation, proceeding, complaint, charge, claim, demand or investigation (any "Action") arising out of or relating to this Assignment, and hereby irrevocably agrees that all claims in respect of such Action may be heard and determined in such New York state or federal court. Each party hereto hereby irrevocably waives, to the fullest extent that it may effectively do so, the defense of an inconvenient forum to the maintenance of such Action. The parties hereto further agree, to the extent permitted by law, that final and unappealable judgment against any of them in any Action contemplated above shall be conclusive and may be enforced in any other jurisdiction within or outside the United States by suit on the judgment, a certified copy of which shall be conclusive evidence of the fact and amount of such judgment.

SECTION 10. WAIVER OF JURY TRIAL. EACH PARTY TO THIS ASSIGNMENT WAIVES TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM BROUGHT BY ANY OF THEM AGAINST THE OTHER

ARISING OUT OF OR IN ANY WAY CONNECTED WITH THIS ASSIGNMENT,
OR ANY OTHER AGREEMENTS OR ASSIGNMENTS EXECUTED IN
CONNECTION HERewith OR THE ADMINISTRATION THEREOF OR ANY OF
THE TRANSACTIONS CONTEMPLATED HEREIN OR THEREIN.


