TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Termination") is executed as of June 2, 2017, by Wells Fargo Bank, National Association ("Wells Fargo"), with reference to (i) the Patent and Trademark Security Agreement, executed by Wells Fargo and Capstone Turbine Corporation ("Company"), dated February 9, 2009, which was recorded with the United States Patent and Trademark Office on February 23, 2009, at reel/frame number 022320/0030 and at reel/frame number 3950/0099, and (ii) the First Amendment to Patent and Trademark Security Agreement, executed by Wells Fargo and Company, dated June 2, 2010, which was recorded with the United States Patent and Trademark Office on June 18, 2010, at reel/frame number 004228/0227 and at reel/frame number 024563/0073 (collectively, and as otherwise amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Initially capitalized terms not defined in this Termination shall have the meanings set forth in the Security Agreement.

WHEREAS, the Company granted Wells Fargo, under the terms of the Security Agreement, a lien on and continuing security interest (the "Security Interest") in favor of Wells Fargo in and to all rights, title and interest in certain of Company's patents and trademarks, including, without limitation, the patents and trademarks listed in Exhibits A and B attached hereto (collectively, the "Company Patents and Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Company's trademarks.

WHEREAS, Wells Fargo has agreed to terminate and release its collateral pledge, grant, assignment, Security Interest, lien and all right, title and interest in all such Company Patents and Trademarks as herein provided.

For good and valuable consideration, receipt of which is hereby acknowledged, Wells Fargo hereby:

1. releases, cancels, terminates and discharges the Security Interest granted to Wells Fargo by Company with respect to all patents and trademarks described in the Security Agreement, including, but not limited to the Company Patents and Trademarks and all of the goodwill of the business connected with the use of, and symbolized by the Company's trademarks; and
2. to the extent Wells Fargo shall be deemed to have any right, title or interest in the Company Patents and Trademarks, retransfers, reconveys and reassigns to Company all of the right, title and interest in such intellectual property, including the Security Interest and any other liens without recourse and without representation or warranty of any kind whatsoever.

Wells Fargo hereby authorizes and requests that the Commissioner for Patents and

Trademarks and any other governmental official record this Termination. This Termination shall be governed by the laws of the State of California.


