**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of June 21, 2017 (this "Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as agent (in such capacity, the "Agent"), in favor of SAFWAY SERVICES, LLC, a Delaware limited liability company ("Safway"), SAFWAY GROUP HOLDING LLC, a Delaware limited liability company ("SGH"), NORTH AMERICAN COATINGS, LLC, a Delaware limited liability company ("NAC"), ALL-AMERICAN SCAFFOLD, LLC, an Iowa limited liability company ("All-American"), REDI SOLUTIONS, LLC, a Utah limited liability company ("Red", and together with Safway, SGH, NAC and All-American, the "Debtors" and each, a "Debtor").

**WITNESSETH**

WHEREAS, pursuant to the Amended and Restated Trademark Collateral Assignment and Security Agreement, dated August 19, 2016 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on August 24, 2016 at Reel/Frame 5862/0376, the Debtor's granted to the Agent a security interest in all of Debtors right, title and interest in and to the following, whether now owned or hereafter acquired or arising (collectively, the "Released Trademark Collateral"):

(a) all of such Debtor's now existing or hereafter acquired right, title and interest in and to all of such Debtor's trademarks, trade names, tradestyles and service marks; all prints and labels on which said trademarks, trade names, tradestyles and service marks appear, have appeared or will appear, and all designs and general intangibles of a like nature; all applications, registrations and recordings relating to the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof, any political subdivision thereof or in any other countries, and all reissues, extensions and renewals thereof including, without limitation, those trademarks, service marks, terms, designs and applications described on Exhibit A hereto (the "Trademarks");

(b) the goodwill of the business symbolized by each of the Trademarks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks; and

(c) any and all proceeds of any of the foregoing, including, without limitation, any claims by such Debtor against third parties for infringement of the Trademarks or any licenses with respect thereto.

WHEREAS, the Debtors have requested that the Agent release its security interest in all of the Released Trademark Collateral.

NOW, THEREFORE, the Agent, on behalf of itself, its successors, legal representatives and assigns and any lenders for which the Agent acted as security or collateral agent, without recourse, representation or warranty of any kind or nature, hereby terminates, cancels and releases its security interest in, lien upon and conditional assignments of, and hereby reassigns to the Debtor, all of the Released Trademark Collateral.

The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of New York.

Capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Security Agreement.

Delivery of an executed signature page to this Release by facsimile or electronic transmissions (including .pdf file) shall be effective as delivery of an original signature.
