TRADEMARK RELEASE

THIS TRADEMARK RELEASE by Design Investors WW Acquisition Company, LLC, a Delaware limited liability company (the "Secured Party"), in favor of Waterworks IP Co., LLC, a Delaware limited liability company ("Company") is dated as of June 27, 2017 to effectuate the release of the Secured Party's security interest in the Intellectual Property (as defined in the Assignment referred to below) pursuant to the Contribution and Termination Agreement by and between the Secured Party, Waterworks Holdings, LLC and the Company dated as of May 23, 2016.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Secured Party hereby unconditionally and expressly releases, terminates, and extinguishes, without any representation, recourse or undertaking of any kind, any and all of its right, title and interest in and to any and all liens on and security interests it may have upon the Intellectual Property, including without limitation the trademarks and trademark applications listed on Schedule A attached hereto and made a part hereof, which liens and security interests were established under and pursuant to that certain Grant of Security Interest in United States Trademarks dated as of December 20, 2005, (as amended, restated or otherwise modified from time to time, the "Original Grant"), executed by PDF Associates, Inc., a Connecticut corporation ("PDS"), in favor of The Governor and Company of the Bank of Ireland ("Original Secured Party") recorded with the United States Patent and Trademark Office at reel number 003217 and frame number 0629. PDS merged with Waterworks, Inc. ("Waterworks Inc.") on December 20, 2005, and the Intellectual Property was subsequently assigned to Waterworks Inc. pursuant to a trademark assignment recorded with the United States Patent and Trademark

Office at reel number 003568 and frame number 0134. The liens and security interests in the Intellectual Property held by Original Secured Party were later assigned pursuant to that certain Assignment of Security Interest dated as March 19, 2009 (as amended, restated or otherwise modified from time to time, the "Assignment") by the Original Secured Party in favor of the Secured Party recorded with the United States Patent and Trademark Office at reel number 003956 and frame number 0169. Waterworks Inc.'s entire interest and goodwill in the Intellectual Property was assigned to the Company pursuant to a trademark assignment recorded with the United States Patent and Trademark Office at reel number 004031 and frame number 0974.


