RELEASE OF SECOND LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of July 3, 2017 (this "**Release**"), by Credit Suisse AG, Cayman Islands Branch, as administrative agent (the "**Administrative Agent**") for the Finance Parties. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement, the Guarantee and Collateral Agreement, the Copyright Security Agreement or the Trademark Security Agreement, as applicable, referred to below (and in the event a term is defined differently in the Credit Agreement, the Guarantee and Collateral Agreement, the Copyright Security Agreement and the Trademark Security Agreement, the applicable definition shall be the one given to such term in the Guarantee and Collateral Agreement).

A. Reference is made to (i) the Second Lien Credit Agreement dated as of September 19, 2016 (as amended, restated, supplemented or otherwise modified to the date hereof, the "**Credit Agreement**"), among Bowlmor AMF Corp., a Delaware corporation ("**Holdings**"), AMF Bowling Centers Inc., a Virginia corporation (the "**Borrower**"), the various lenders from time to time party thereto and the Administrative Agent, (ii) the Second Lien Guarantee and Collateral Agreement dated as of September 19, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "**Guarantee and Collateral Agreement**") among Holdings, the Borrower, the subsidiaries from time to time party thereto and Credit Suisse AG, Cayman Islands Branch as collateral agent (the "**Collateral Agent**"), (iii) the Second Lien Copyright Security Agreement dated as of September 19, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "**Copyright Security Agreement**") among the grantors party thereto (the "**Copyright Grantors**") and the Collateral Agent, and (iv) the Second Lien Trademark Security Agreement dated as of September 19, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "**Trademark Security Agreement**") among the grantors party thereto (the "**Trademark Grantors**") and, together with the Copyright Grantors, the "**Grantors**") and the Collateral Agent (such documents set forth in clauses (i) through (iv), the "**Security Documents**").

B. Pursuant to the Security Documents, the Grantors granted to the Administrative Agent, for the benefit of the Finance Parties, a security interest in all of such Grantor's right, title, and interest in and to the Article 9 Collateral consisting of Intellectual Property (as defined in the Guarantee and Collateral Agreement), the Copyright Collateral (as defined in the Copyright Security Agreement), the Trademark Collateral (as defined in the Trademark Security Agreement) (collectively, the "**IP Collateral**"), which shall include, without limitation and for purposes hereof, the following:

(i) all Trademarks, including as set forth on Schedule I hereto, which security interest was recorded with the United States Patent & Trademark Office on September 22, 2016 at Reel 5882, Frame 053;

(ii) all Copyrights, including as set forth on Schedule II hereto, which security interest was recorded with the United States Copyright Office on September 23, 2016 at Volume 9925, Document 465; and

(iii) all other Article 9 Collateral consisting of Intellectual Property (as defined in the Guarantee and Collateral Agreement), Copyright Collateral (as defined in the Copyright Security Agreement) and Trademark Collateral (as defined in the Trademark Security Agreement).

C. Pursuant to the Payoff Letter dated as of July 3, 2017 among the Administrative Agent and the Borrower, the Administrative Agent agreed to release any and all interests it may have in the IP Collateral pursuant to the Security Documents.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of the Finance Parties, does hereby terminate, release, relinquish and discharge its security interests in the IP Collateral and any right, title or interest it has in the IP Collateral granted pursuant to the Security Documents shall hereby cease and become void as provided for in the Security Documents. This Release is made without representation or warranty by, or recourse to, the Administrative Agent or any other Finance Party.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to affect the release of the security interest contemplated hereby. The Administrative Agent further agrees to make filings with the United States Patent and Trademark Office and the United States Copyright Office and other necessary filings, in each case as reasonably requested by the Borrowers and at the expense of the Borrowers, to evidence the release and termination of the Administrative Agent's security interests in the IP Collateral.


