THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS EVIDENCED HEREBY ARE SUBORDINATE IN THE MANNER AND TO THE EXTENT SET FORTH HEREIN AND IN THE SUBORDINATION AND INTERCREDITOR AGREEMENT, DATED AS OF JUNE 30, 2017 (THE "SUBORDINATION AND INTERCREDITOR AGREEMENT"), BY AND AMONG ROBERTS-GORDON LLC, THE OTHER OBLIGORS FROM TIME TO TIME PARTY THERETO, STELLUS CAPITAL INVESTMENT CORPORATION, STELLUS CREDIT MASTER FUND II, LLC, STELLUS CREDIT VCOC FUND II, LLC, IN THEIR CAPACITIES AS "SUBORDINATED CREDITORS" UNDER AND AS DEFINED THEREIN, BNP PARIBAS (TOGETHER WITH ITS SUCCESSORS AND ASSIGNS), IN ITS CAPACITY AS "ADMINISTRATIVE AGENT" UNDER AND AS DEFINED THEREIN. THE SUBORDINATED CREDITORS, BY ITS THEIR ACCEPTANCE HEREOF, IRREVOCABLY AND UNCONDITIONALLY AGREE TO BE BOUND BY THE PROVISIONS OF THE SUBORDINATION AND INTERCREDITOR AGREEMENT.

GRANT OF TRADEMARK SECURITY INTEREST

This Grant of Trademark Security Interest (this "Grant of Trademark Security Interest") is made as of June 30, 2017, by Roberts-Gordon LLC, a Delaware limited liability company (the "Company"), Rapid Engineering LLC, a Delaware limited liability company ("Rapid"), Weather-Rite LLC, a Delaware limited liability company ("Weather-Rite"), PoolPak LLC, a Delaware limited liability company ("Addison HVAC LLC, a Delaware limited liability company ("Addison HVAC") and together with the Company, Rapid, Weather-Rite, and PoolPak, each a "Grantor" and collectively, the "Grantors"), in favor of STELLUS CAPITAL INVESTMENT CORPORATION, as Administrative Agent for and representative of (in such capacity, "Secured Party") the Beneficiaries. Capitalized terms used in this Grant of Trademark Security Interest and not otherwise defined herein have the meanings specified in the Security Agreement (as defined below).

WHEREAS, pursuant to the Senior Subordinated Second Lien Credit Agreement, dated as of June 30, 2017 (said Credit Agreement, as it may heretofore have been and as it may hereafter be amended, restated, supplemented or otherwise modified from time to time, being the "Credit Agreement") by and between the Company, the financial institutions listed therein (the "Lenders"), and Stellus Capital Investment Corporation, as Administrative Agent, Lenders have made certain commitments, subject to the terms and conditions set forth in the Credit Agreement, to extend certain credit facilities to Company; and

WHEREAS, it desired that all obligations of the Company under the Credit Agreement and the other Loan Documents, be secured under the Security Agreement and this Grant of Trademark Agreement; and

WHEREAS, Rapid, Weather-Rite, PoolPak, and Addison HVAC each executed and delivered that certain Subsidiary Guaranty dated as of June 30, 2017 (said Subsidiary Guaranty, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Guaranty") in favor of Secured Party for the benefit of Lenders, pursuant to which each Grantor has guaranteed the prompt payment and performance when due of all obligations of Company under the Credit Agreement and the other Loan Documents; and

WHEREAS, pursuant to the terms of the Security Agreement dated as of June 30, 2017 (said Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Security Agreement"), among Company, Secured Party, each other Grantor, including each Additional Grantor, and the other grantors named therein, each Grantor has granted to the Secured Party a security interest in and to the Collateral, including the Trademark Collateral (as hereinafter defined);

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by each Grantor to Secured Party pursuant to the Security Agreement, each Grantor hereby grants to Secured Party a security interest in all of such Grantor's right, title and interest in and to the following, in each case, whether now owned or hereafter acquired (the "**Trademark Collateral**"):

- (i) all trademarks, service marks, designs, logos, indicia, tradenames, trade dress, domain names, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto (owned by a Grantor, or hereafter adopted and used, in its business, including, without limitation, the trademark applications and trademark registrations set forth on <u>Schedule A</u> annexed hereto) (collectively, the "**Trademarks**"),
- (ii) all registrations and applications for registration of Trademarks that have been or may hereafter be issued or applied for in the United States and any state thereof and in foreign countries (including, without limitation, the registrations and applications set forth on Schedule A annexed hereto) (collectively, the "Trademark Registrations"),
- (iii) all common law and other rights in and to Trademarks in the United States and any state thereof and in foreign countries (collectively, the "**Trademark Rights**"),
 - (iv) all goodwill of the business symbolized by and associated therewith; and
- (v) all proceeds thereof (such as, by way of example and not by limitation, license royalties and proceeds of infringement suits).

Notwithstanding anything to the contrary, in no event shall the Trademark Collateral include, nor shall any Grantor be deemed to have granted a security interest in any application for registration of a Trademark filed with the United States Patent and Trademark Office on an intent-to-use basis until such time (if any) as a statement of use or amendment to allege use is accepted by the United States Patent and Trademark Office, at which time such Trademark Registration shall automatically become part of the Trademark Collateral and the security interest granted hereunder.

Each Grantor hereby further acknowledges and affirms that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement.

In the event that any provision of this Grant of Trademark Security Interest is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

THIS GRANT OF TRADEMARK SECURITY INTEREST AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE INTERNAL LAWS OF THE STATE OF NEW YORK (INCLUDING, WITHOUT LIMITATION, SECTION 5-1401 OF THE GENERAL OBLIGATIONS LAW OF THE STATE OF NEW YORK), WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES. EXCEPT TO THE EXTENT THAT THE UCC PROVIDES THAT THE PERFECTION OF THE SECURITY INTEREST HEREUNDER, OR REMEDIES HEREUNDER, IN RESPECT OF ANY PARTICULAR COLLATERAL ARE GOVERNED BY THE LAWS OF A JURISDICTION OTHER THAN THE STATE OF NEW YORK, IN WHICH CASE THE LAWS OF SUCH JURISDICTION SHALL GOVERN WITH RESPECT TO THE PERFECTION OF THE

SECURITY INTEREST IN, OR THE REMEDIES, WITH RESPECT TO, SUCH PARTICULAR COLLATERAL.
