TERMINATION AND RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

NOW, THEREFORE, in consideration of the foregoing and intending to be legalty bound, the Security Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby (i) absolutely, unconditionally and irrevocably releases, terminates, cancels and forever discharges all liens and the Security Interest, waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantor and its successors and assigns in association with the Security Interest, including those intellectual property and such intellectual property applications set forth herein on Schedule A, in each case arising under the Security Agreement or the Intellectual Property Supplement (collectively, the "Intellectual Property") and any and all other security interests or liens that the Security Agent or its predecessors, successors, assigns and transferees may have in or to the Intellectual Property under the Security Agreement or the Intellectual Property Supplement, and (ii) absolutely, unconditionally and irrevocably terminates the Intellectual Property Supplement and hereby releases Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest. The Security Agent authorizes and requests the Director of Patents and Trademarks of the United States of America to record this Termination and Release of Security Interest in Intellectual Property and agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as the Grantor may reasonably request, at Grantor's sole cost and expense, in order to perfect, confirm or evidence such release. This Termination and Release shall be governed by and construed in accordance with the law of the State of New York. This Termination and Release shall be binding upon the Security Agent's representatives, successors, assigns and transferees.
