## U.S. TRADEMARKS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of June 30, 2017 by ROYAL BANK OF CANADA, as administrative agent (in such capacity, the “**Agent**”) for the Secured Creditors. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Existing Credit Agreement or in the NY Security Agreement referred to below, as applicable.

A. Reference is made to the Amended and Restated Senior Secured Credit Agreement dated as of March 14, 2014, (as amended, supplemented or otherwise modified prior to the date hereof, the “**Existing Credit Agreement**”), among DHX Media Ltd., as Borrower (the “**Borrower**”), the subsidiaries of the Borrower that are listed on the signature pages thereto (and that may have been added from time to time) as Guarantors, the financial institutions that are listed on the signature pages and may be added from time to time as Lenders, Royal Bank of Canada, as administrative agent and RBC Capital Markets as Lead Arranger and Sole Bookrunner.

B. Reference is made to (i) the Guarantee and Security Agreement, dated as of October 22, 2012 between Borrower, each of the subsidiaries of the Borrower identified on Annex 1 thereto and each entity that became a Guarantor thereunder, and the Agent (as amended, supplemented or otherwise modified prior to the date hereof, the “**NY Security Agreement**”), (ii) the Short-Form Trademarks Security Agreement, dated October 22, 2012 among the Grantors party thereto and as may have been added from time to time (as amended, supplemented or otherwise modified prior to the date hereof, the “**Initial Trademark Security Agreement**”), (iii) the Intellectual Property Security Agreement, dated as of October 31, 2013, by DHX Media Ltd. and certain of its Restricted Subsidiaries listed on the signature pages thereto, in favor of the Agent (the “**2013 Intellectual Property Security Agreement**”), and (iv) the Intellectual Property Security Agreement, dated as of October 16, 2014 by DHX Media Ltd. and certain of its Restricted Subsidiaries listed on the signature pages thereto, in favor of the Agent (the “**2014 Intellectual Property Security Agreement**”), and together with the NY Security Agreement, the Initial Trademark Security Agreement, and the 2013 Intellectual Property Security Agreement, the “**Existing Trademark Security Agreements**”). Pursuant to the Existing Trademark Security Agreements, the Borrower and each of the subsidiaries of the Borrower party to any Existing Trademark Security Agreement granted a security interest to the Agent, for the benefit of the Secured Creditors, in, among other things, the registered trademarks and trademark applications of the Borrower and such subsidiaries of the Borrower set forth on Schedule I hereto (the “**Trademarks**”), which security interest was recorded with the United States Patent & Trademark Office at the reels and frames as set forth on Schedule I.

C. In connection with the termination of the Existing Credit Agreement and the Existing Trademark Security Agreements, the Borrower and each subsidiary of the Borrower party to an Existing Trademark Security Agreement have informed the Agent of their desire to obtain the release of all right, title and interest of the Agent and the Secured Creditors and each other grantee or beneficiary in and to the Trademarks granted under the Existing Trademark Security Agreements and the other Credit Documents.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, all the Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Existing Trademark Security Agreements and the other Credit Documents shall hereby automatically terminate (without any recourse, representation, warranty (express or implied) or undertaking of any kind or nature), including, without limitation, the Trademarks set forth on Schedule I attached hereto, the debt secured thereby having been paid and satisfied in full.
