**TERMINATION AND RELEASE OF SENIOR SUBORDINATED INTELLECTUAL  
PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF SENIOR SUBORDINATED INTELLECTUAL PROPERTY SECURITY AGREEMENT** (“Release”) is executed as of July 20, 2017, by MVC CAPITAL, INC. (the “Secured Party”), in favor of PRIDE ENGINEERING, LLC (the “Released Party”).

**WHEREAS**, pursuant to the terms of that certain Senior Subordinated Intellectual Property Security Agreement dated as of December 18, 2015, by and between Released Party and Secured Party (the “Security Agreement”) as recorded with the United States Patent and Trademark Office (“USPTO”) on April 14, 2016, at Reel 038278, Frame 0034 (with respect to the patents and patent applications set forth on Schedule 1) at Reel 5770, Frame 0922 (with respect to the trademark registrations and applications set forth on Schedule 2), the Released Party granted to Secured Party a security interest in and lien on the patents and patent applications identified on Schedule 1 attached hereto and on the trademark registrations and applications identified on Schedule 2 attached hereto; and

**WHEREAS**, Secured Party wishes to release the security interest in and lien on the patents and patent applications identified on Schedule 1 attached hereto and on the trademark registrations and applications set forth on Schedule 2 attached hereto (together with all other IP Collateral (as defined in the Security Agreement), collectively the “Collateral”).

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party states as follows:

Secured Party hereby terminates, releases, and discharges its security interest in and lien on the Collateral, and Secured Party hereby assigns and transfers to the Released Party without recourse or representation or warranty, express or implied, of any kind, all of its right, title and interest in and to the Collateral together with the goodwill of the business symbolized thereby, including, effective as of the date set forth above.


Secured Party understands and agrees that this Release may be recorded by or for the Released Party with the USPTO or any similar office or agency within or outside the United States.
