ASSIGNMENT OF TRADEMARKS

Assignor hereby authorizes and requests the Register of the U.S. Patent and Trademark Office, whose duty is to issue trademark registrations or other evidence or forms of intellectual property or industrial property protection on applications, to issue the same to the Assignee, its successors, legal representatives and assigns, with respect to the Trademarks in accordance with the terms of this Assignment and to record and register this Assignment upon request of Assignee.

3. Assignor hereby agrees to execute, upon the request of Assignee, such additional instruments, documents and papers as are necessary to give full effect to and to perfect the rights of Assignee under this Assignment in and to the Trademarks.

4. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same instrument. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Ohio without giving effect to any choice or conflict of law provision or rule.
