TRADEMARK SECURITY AGREEMENT

As of August 1, 2017, OutSol, LLC, a Delaware Limited Liability Company (together with its successors and assigns "Debtor") for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, grants to Asana Ventures, LLC ("Secured Party") as collateral agent for itself a continuing security interest in the following property:

(i) All claimed Trademarks, Trademark registrations and Trademark applications of Outsol, LLC, as further listed on Schedule A hereto, either acquired or subsequently acquired, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark, Trademark registration and Trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any Trademark or Trademark registration listed in Schedule A hereto or by reason of injury to the goodwill associated with any such Trademark or Trademark registration or Trademark license, in each case together with the right to sue for and collect said damages to secure performance of all Secured Obligations of Debtor as described or referred to in that certain Security Agreement dated as of February 1, 2015, by and between Debtor and Secured Party (the "Agreement").


Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Trademarks, Trademark registrations and Trademark applications made and granted hereby are more fully set forth in the Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. Debtor shall execute a power of attorney in favor of Secured Party to exercise to exercise its rights in the event of Default under the Agreement.

All terms defined in the Agreement, whether by reference or otherwise, when used herein, shall have their respective meanings set forth therein, unless the context requires otherwise. This Trademark Security Agreement may be executed and delivered in counterparts, including by electronic transmission.
