**CERTIFICATE OF AMENDMENT OF CERTIFICATE
OF INCORPORATION OF GENECENTRIC DIAGNOSTICS, INC.**

GeneCentric Diagnostics, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "*Corporation*"), does hereby certify as follows:

FIRST: That the Corporation's original Certificate of Incorporation was filed with the Secretary of State of Delaware on June 6, 2011, as amended by that certain Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on September 2, 2011, as amended by that certain Second Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on June 19, 2013, and as amended by that certain Third Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on December 22, 2016 (the "*Certificate of Incorporation*").

SECOND: That the Board of Directors of the Corporation duly adopted resolutions by written consent proposing and declaring advisable the amendment of the Certificate of Incorporation of the Corporation, as follows:

Paragraph ARTICLE I of the Certificate of Incorporation be replaced and amended to read in its entirety as follows:

"ARTICLE I.

The name of the corporation is GeneCentric Therapeutics, Inc. (the "*Corporation*")."

THIRD: That the stockholders of the Corporation approved and adopted such amendment by written consent in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

FOURTH: That such amendment of the Certificate of Incorporation of the Corporation was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
