IP ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (The "IP Assignment Agreement") is made and entered into on this 24th day of January 2017 (the "Effective Date") by and among Radiancy, Inc., a Nevada corporation, company number NV19981264651, whose registered office is located at 40 Ramland Road South, Suite 200, Orangeburg, New York 10962 (each an "Assignor" and together, the "Assignors"), and ICTV Brands, Inc., a Nevada corporation, company number NV19981264651 whose registered office is located at 489 Devon Park Drive, Suite 306, Wayne, Pennsylvania 19087 (the "Assignee").

Whereas the Assignors and the Assignee have entered into an Asset Purchase Agreement by and among the Assignee and the Assignors dated October 5, 2016 (the "Agreement"), pursuant to which the Assignors wish to assign all the intellectual property rights in the Purchased IPR (as defined in the Agreement) to the Assignee.

NOW, THEREFORE, in consideration of the terms and conditions set forth herein each of the Assignors and the Assignee agree as follows:

I. Assignment

1.1. In consideration of and exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignors, jointly and severally, hereby assign, sell, transfer, convey and deliver to the Assignee their entire right, title and interest in and to all intellectual property used or held for use by any Assignor in the business (as defined in the Agreement), including, without limitation:

- a) United States and foreign patents, patent applications, continuations, continuations-in-part, divisions, and reissues (collectively, the "Patents");
- b) United States and foreign trademarks, service marks, logos, trade dress and trade names or other source-identifying designations or devices together with the goodwill of the business connected with the use of, and symbolized by the foregoing, and together with all applications and/or registrations thereof (collectively, the "Trademarks");
- c) United States and foreign designs, design-patents, models, and pending applications to register the same (collectively, the "Designs");
- d) United States and foreign copyrights, whether registered or unregistered, and pending applications to register the same (collectively, the "Copyrights");
- e) business and internet domain names and registrations thereof (collectively, the "Domains");
- f) All claims, demands and causes of action which relate to any use, infringement or misappropriation by any third party of any of the Patents, Trademarks, Designs, Copyrights or Domains, including rights to all past damages and profits by reason of infringement or misappropriation that have occurred prior to the Effective Date and to sue for and collect the same by the Assignee for the use and benefit of the Assignee and its successors, assigns and legal representatives.

Schedule X to the Agreement, and attached hereto, sets forth a true and complete list of all of the Patents, Trademarks, Designs, Copyrights and Domains, forming part of the Purchased IPR. Should any transferred property not be listed on these Schedules, the Schedules can be amended at a later time to reflect such transfer.

- 1.2. Each of the Assignors hereby agree to execute and deliver, at the request of the Assignee or its representatives all papers, documents and instruments, needed in order to record the assignment of all Patents, Trademarks, Designs, Copyrights and/or Domains to the Assignee and/or its designee. Each Assignor further agrees to perform any other reasonable acts the Assignee may require, and agrees to assist the Assignee to obtain the exclusive and absolute rights, title and interests in and to all the intellectual property assigned hereunder, and to protect the same against infringement by any third party.
- 1.3. Each Assignor hereby irrevocably designates and appoints the Assignee and its duly authorized officers and agents, to act for or on its behalf and to execute and file any such applications and documents and to do all other lawfully permitted acts to further the prosecution and issuance of the Patents, Trademarks, Designs, Copyrights or Domains registrations, or to evidence, perfect or facilitate transfers or assignments thereof of any other intellectual property assigned hereunder, with the same legal force and effect as if executed by such Assignor.


2. Miscellaneous

- 2.1. In the event of any conflict or inconsistency between the provisions of the Agreement and the provisions of this IP Assignment Agreement, the provisions of the Agreement will control.
- 2.2. The Assignors are jointly and severally liable under this IP Assignment Agreement.
- 2.3. This IP Assignment Agreement and all obligations hereunder will be governed by and construed in accordance with the laws of the State of New York without giving effect to any choice or conflict of law provision or rule. Each party hereto hereby submits to the exclusive jurisdiction of the United States District Court for the Southern District of New York and of any New York State Court sitting in the County of New York, State of New York for all disputes arising out of or in connection with this IP Assignment Agreement or the transactions contemplated hereby. Each party hereto hereby irrevocably waives any and all right to trial by jury in any legal proceeding arising out of or relating to this IP Assignment Agreement or the transactions contemplated hereby.
- 2.4. This IP Assignment Agreement may be executed in counterparts, all of which when taken together shall be considered one and the same agreement.


