UNITED STATES TRADEMARK SECURITY AGREEMENT

This UNITED STATES TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) dated as of August 28, 2017, is made by and between WELLS FARGO BANK, NATIONAL ASSOCIATION for itself and on behalf of other holders of Secured Obligations as defined in the Credit Agreement referred to below (in such capacity, together with its successors and assigns, the “**Lender**”) and THE GIORGI COMPANIES, INC., a Delaware corporation (“**Borrower**”), DIGIORGIO MUSHROOM CORP., a Pennsylvania corporation (“**DMC**”), GIORGI MUSHROOM CO., a Pennsylvania corporation (“**GMC**”), CAN CORPORATION OF AMERICA, INC., a Pennsylvania corporation (“**Can Corp**”), ASCOLI REALTY CORPORATION, a Pennsylvania corporation (“**ARC**”), CCA OF INDIANA, INC., an Indiana corporation (“**CCA Indiana**”), GIORGIO FOODS, INC., a Pennsylvania corporation (“**GF**”), GIORGIFRED COMPANY, a Delaware corporation (“**GC**”), MAIDENCREEK PLAZA CO., a Pennsylvania limited liability company (“**MPC**”), GIORGIO FOODS XPRESS, LLC, a Pennsylvania limited liability company (“**GFEC**”), GIORGIO FRESH CO., a Pennsylvania corporation (“**GFC**”), ONTELAUNEE FARMS, INC., a Pennsylvania corporation (“**OFI**”), GASPARI FARMS, INC., a Pennsylvania corporation (“**GFI**”), GASPARI FARM PRODUCTS, INC., a Pennsylvania corporation (“**GFPI**”), DEW FRESH, INC., a Pennsylvania corporation (“**DFI**”), ALL SEASONS PRODUCTS, INC., a Pennsylvania corporation (“**ASPI**”), MOUNT JOY HOLDING CO., a Pennsylvania limited liability company (“**MJHC**”), and BLANDON LAND COMPANY LLC, a Pennsylvania limited liability company (“**BLC**”), AUTOMATED COMPOST TRANSPORT, INC., a Pennsylvania corporation (“**ACTI**”), VILLA RIMINI, INC., a Pennsylvania corporation (“**VRI**”), and VALENTIA LTD., a Pennsylvania limited liability company (“**VL**”) (each of Borrower, DMC, GMC, Can Corp, ARC, CCA Indiana, GF, GC, MPC, GFEC, GFC, OFI, GFI, GFPI, DFI, ASPI, MJHC, BLC, ACTI, VRI and VL, a “**Grantor**”, and collectively, with each of their respective successors and assigns, the “**Grantors**”).

WHEREAS, this Agreement will be filed with the United States Patent and Trademark Office to among other things indicate that Lender is collateral assignee with respect to the Marks (as defined herein) listed on Schedule A hereto;

WHEREAS, each Grantor is the owner of certain trademarks, trade names, corporate names, company names, business names, fictitious business names, trade dress, service marks, logos, designs, domain names and other source or business identifiers now existing and hereafter adopted or acquired, including, without limitation, those listed on Schedule A hereto listed with their name, together with pending applications and/or registrations therefor, all registrations and recordings thereof, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States or any State thereof, or otherwise, all rights to obtain any reissues, renewals or extensions of the foregoing, all common law rights related thereto, the goodwill associated therewith, all licenses for any of the foregoing, and all causes of action arising prior to or after the date hereof for infringement, dilution, misappropriation, violation and unfair competition of or regarding the same, (collectively, the “**Marks**”); and

WHEREAS, Grantors and Lender entered into that certain Credit Agreement, dated as of August 28, 2017 (as the same may be amended, restated, modified, supplemented and/or

replaced from time to time, the “**Credit Agreement**”), pursuant to which the Lender may make certain loans and other extensions of credit to Borrower (and other related entities) on the terms and conditions described therein; and

WHEREAS, one of the conditions to the extension of credit under the Credit Agreement is that payment shall be secured by, among other things, a security interest in favor of the Lender in the Marks.


NOW, THEREFORE, for good and valuable consideration, each Grantor hereby pledges and grants (and confirms and ratifies all other pledges and grants heretofore made) to Lender a security interest and lien in and to the Marks (to the extent applicable to such Grantor, and excluding any application for registration of any of the Marks filed on an intent-to-use basis solely to the extent that the grant of a security interest in any such application would materially adversely affect the validity or enforceability of the Mark, the corresponding application, or the resulting registration of the Mark or result in cancellation of such application or registration). The parties acknowledge and agree that the terms of such grant are more fully set forth in other loan documents entered into in connection with the Credit Agreement, and the grant referred to in this Agreement does not restrict those provisions in any way.
