**AMENDED AND RESTATED CERTIFICATE OF INCORPORATION**

**BOT HOME AUTOMATION, INC.**

Bot Home Automation, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

The Board of Directors of the Corporation duly adopted, pursuant to Sections 141(f) and 242 of the General Corporation Law of Delaware, a resolution setting forth an amendment to the Amended and Restated Certificate of Incorporation of the Corporation and declaring said amendment to be advisable. The stockholders of the Corporation duly approved said proposed amendment by written consent in accordance with Sections 228 and 242 of the General Corporation Law of the State of Delaware. The resolution setting forth the amendment is as follows:

**RESOLVED:** That the Amended and Restated Certificate of Incorporation of the Corporation (the "Restated Certificate") be amended as follows:

1. The Restated Certificate is hereby amended by deleting Article FIRST thereof and inserting the following in lieu thereof:

"FIRST: The name of this corporation is Ring Inc. (the "Corporation")."

2. That the first sentence of Article FOURTH of the Restated Certificate be and hereby is deleted in its entirety and the following sentence is inserted in lieu thereof:

"The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) 75,000,000 shares of Common Stock, \$0.0001 par value per share ("Common Stock"), and (ii) 54,724,949 shares of Preferred Stock, \$0.0001 par value per share ("Preferred Stock"), of which (A) 1,874,025 shares shall be designated "Series Seed Preferred Stock," (B) 5,328,213 shares shall be designated "Series A Preferred Stock," (C) 3,113,380 shares shall be designated "Series A-1 Preferred Stock," (D) 11,541,021 shares shall be designated "Series B Preferred Stock," (E) 18,531,935 shares shall be designated "Series C Preferred Stock" and (F) 14,336,375 shares shall be designated "Series D Preferred Stock.""
