**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT (TRADEMARKS)**

This Termination and Release of Intellectual Property Security Agreement (Trademarks) (the "Release") is conveyed as of July **31**, 2017, by **BANK OF AMERICA, N.A.** ("Bank of America"), as administrative agent under the agreements referred to below (in such capacity, the "Administrative Agent"), in favor of the Grantors (as hereinafter defined). Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Trademark Security Agreements (as hereinafter defined), as applicable.

Reference is made to (i) that certain Loan Agreement, dated as of April 13, 2007 (as amended or otherwise modified prior to the date hereof, the "2007 Loan Agreement"), by and among **BCBG MAX AZRIA GROUP, LLC** (as successor by conversion to BCBG Max Azria Group, Inc., the "Borrower"), **BCBG MAX AZRIA CANADA INC.** (the "Canadian Borrower"), **BCBG MAXAZRIA HOLDINGS, INC.** ("Holdings"), **BCBG MAXAZRIA INTERNATIONAL HOLDINGS, INC.** ("International Holdings"), each other guarantor party thereto, the Administrative Agent, Bank of America, N.A. (acting through its Canadian branch) as Canadian agent ("Canadian Agent"), and the other lenders from time to time party thereto, (ii) that certain Amended and Restated Loan Agreement, dated as of August 3, 2010 (as amended or otherwise modified prior to the date hereof, the "2010 Loan Agreement"), by and among the Borrower, the Canadian Borrower, Holdings, International Holdings, each other guarantor party thereto, the Administrative Agent, the Canadian Agent, and the other lenders from time to time party thereto, and (iii) that certain Second Amended and Restated Loan Agreement, dated as of February 5, 2015 (as amended, amended and restated, or otherwise modified and in effect as of the date hereof, the "2015 Loan Agreement"), by and among the Borrower, the Canadian Borrower, **BCBG MAX AZRIA INTERMEDIATE HOLDINGS, LLC** ("Intermediate Holdings"), **MLA MULTIBRAND HOLDINGS, LLC** (as successor by conversion to MLA Multibrand Holdings, Inc., "Multibrand"), and **MAX RAVE, LLC** ("Max Rave"), the Administrative Agent, the Canadian Agent, and the other lenders from time to time party thereto; and

WHEREAS, in connection with the 2007 Loan Agreement, the Borrower, Holdings, International Holdings, Multibrand, Max Rave and **STREET BEAT SPORTSWEAR, INC.** ("Street Beat" and together with the Borrower, Holdings, International Holdings, Multibrand, and Max Rave, the "2007 Grantors") entered into that certain Trademark Security Agreement, dated as of April 13, 2007 (as amended, amended and restated, or otherwise modified and in effect as of the date hereof, the "2007 Trademark Security Agreement") with the Administrative Agent, pursuant to which the 2007 Grantors granted to the Administrative Agent a continuing security interest (the "2007 Security Interest") in favor of the Administrative Agent in and to the trademark registrations and trademark applications listed on Schedule A, which was recorded (i) with the United States Patent and Trademark Office on April 18, 2007 at Reel 003524, Frame 0787 and instrument number 900074796, and (ii) with the Canadian Intellectual Property Office on July 16, 2007 as file number 744816; and

WHEREAS, in connection with the 2010 Loan Agreement, the Borrower, Holdings, International Holdings, Multibrand, Max Rave, and Street Beat (the "2010 Grantors") entered into that certain Trademark Security Agreement, dated as of August 3, 2010 (as amended, amended and restated, or otherwise modified and in effect as of the date hereof, the "2010 Trademark Security Agreement") with the Administrative Agent, pursuant to which the 2010 Grantors granted to the Administrative Agent a continuing security interest (the "2010 Security Interest") in favor of the Administrative Agent in and to the trademark registrations and trademark applications listed on Schedule B, which was recorded (i) with the United States Patent and Trademark Office on August 4, 2010 at Reel 004254, Frame 0261 and instrument number 900168590, and (ii) with the Canadian Intellectual Property Office on August 23, 2010 as file number 801251; and

WHEREAS, in connection with the 2015 Loan Agreement, the Borrower, Multibrand, and Max Rave (the "2015 Grantors" and, together with the 2007 Grantors and the 2010 Grantors, the "Grantors" and each, individually, a "Grantor") entered into that certain Trademark Security Agreement, dated as of February 5, 2015 (as amended, amended and restated, or otherwise modified and in effect as of the date hereof, the "2015 Trademark Security Agreement" and, together with the 2007 Trademark Security Agreement and the 2010 Trademark Security Agreement, the "Trademark Security Agreements") with the Administrative Agent, pursuant to which the 2015 Grantors granted to the Administrative Agent a continuing security interest (the "2015 Security Interest" and, together with the 2007 Security Interest and the 2010 Security Interest, the "Security Interest") in favor of the Administrative Agent in and to the trademark registrations and trademark applications listed on Schedule C, which was recorded with the United States Patent and Trademark Office on February 5, 2015 at Reel 005454, Frame 0470 and instrument number 900314937; and


WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Administrative Agent hereby releases, terminates and discharges the Security Interest granted under the Trademark Security Agreements with respect to each Grantor's trademark registrations and trademark applications, including, without limitation, the trademark registrations and trademark applications listed on Schedules A, B, and C, and any right, title or interest of the Administrative Agent in such trademark registrations and trademark applications granted under the Trademark Security Agreements shall hereby cease and become void.
