## **RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST dated as of August 3, 2017 (this "Release") is made and granted by JPMorgan Chase Bank, N.A. (the "Lender") in favor of Southern Imperial, Inc., an Illinois corporation (the "Grantor").

WHEREAS, reference is made to that certain Credit Agreement dated as of July 6, 2015 (as amended, restated, supplemented or modified from time to time, the "Credit Agreement"; capitalized terms used but not defined herein shall have the meanings ascribed to them in the Credit Agreement) among Grantor, the other Loan Parties party thereto and Lender;

WHEREAS, pursuant to the terms of the Pledge and Security Agreement dated as of July 6, 2015 (as amended, restated, supplemented or modified from time to time, the "Security Agreement") among Grantor, the other grantors party thereto and Lender, for and on behalf of the Secured Parties, Grantor has granted to Lender a continuing security interest in all of its Collateral, including all right, title and interest of Grantor in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement referenced below), whether now owned or existing or hereafter acquired or arising, to secure the Secured Obligations;

WHEREAS, pursuant to the Trademark Security Agreement, dated as of July 6, 2015, between Grantor and Lender (the "Trademark Security Agreement"), which was recorded in the records of the United States Patent and Trademark Office on July 10, 2015, at reel 5573, frame 0643, the Grantor granted to the Lender a continuing security interest in all of Grantor's right, title and interest in, to and under the following (collectively, the "Trademark Collateral"):

- (a) each Trademark (as defined in the Security Agreement) owned by Grantor, including, without limitation, each Trademark registration and application listed on Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each such Trademark;
- (b) each License (as defined in the Security Agreement) to which Grantor is a party with respect to any Trademarks; and
- (c) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by Grantor against third parties for (i) past, present or future unfair competition with, violation of intellectual property rights in connection with, injury to, or infringement or dilution of any Trademark owned by Grantor, including, without limitation, any Trademark listed on Schedule 1 hereto, or licensed by Grantor under any License with respect to any Trademark, or (ii) injury to the goodwill associated with the foregoing; and


WHEREAS, the Grantor has requested and the Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate all of its liens and security interests in the Trademark Collateral, (b) release its security interests in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in, to and under the security interests granted to the Lender in the Trademark Collateral.

This Release may be executed in counterparts, each of which when so executed and delivered shall be deemed an original and all of which counterparts taken together shall constitute but one and the same instrument.


