## **RELEASE OF PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT**

This Release of Patent, Trademark and Copyright Security Agreement (this "Release") is made effective as of September 22, 2017, by COBANK, ACB in its capacity as administrative agent for itself and the Lenders (the "Administrative Agent"), to SOUTHERN STATES COOPERATIVE, INCORPORATED, a Virginia agricultural cooperative corporation; SOUTHERN STATES HOLDINGS, INC., a Virginia corporation; SSC INSURANCE AGENCY, INCORPORATED, a Virginia corporation; SOUTHERN STATES UNDERWRITERS, INCORPORATED, a Virginia corporation; SOUTHERN STATES VENTURES, L.C., a Virginia limited company; and VIRGINIA SEED SERVICE, INCORPORATED, a Virginia corporation (collectively, the "Pledgors"), as follows:

WHEREAS, pursuant to that certain Security Agreement (the "Security Agreement"), dated as of January 9, 2001, the Pledgors granted to the Administrative Agent a security interest in intellectual property as security for loans and other obligations;

WHEREAS, pursuant to the Security Agreement, the Pledgors and Administrative Agent entered into a Security Agreement dated as of January 9, 2001 (the "Trademark Security Agreement"), pursuant to which the Pledgors granted to the Administrative Agent a continuing security interest in all right, title and interest of the Pledgors in, to and under certain of the Trademark Collateral (as defined in the Trademark Security Agreement,) included among the trademarks listed on the attached Schedule A, together with, among other things, the goodwill of the business symbolized by the Trademark Collateral and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Trademark Security Agreement Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on January 23, 2001, at Reel 2227 / Frame 0530 (Trademarks);

WHEREAS, pursuant to that certain Amended, Restated and Consolidated Loan and Security Agreement (the "Loan Agreement"), dated as of September 18, 2001, the Pledgors granted to the Administrative Agent a security interest in intellectual property as security for loans and other obligations;

WHEREAS, pursuant to the Loan Agreement, the Pledgors and Administrative Agent entered into an Amended and Restated Trademark Security Agreement dated as of September 18, 2001 (the "Amended and Restated Security Agreement"), pursuant to which the Pledgors granted to the Administrative Agent a continuing security interest in all right, title and interest of the Pledgors in, to and under certain of the Trademarks (as defined in the Amended and Restated Trademark Security Agreement,) included among the trademarks listed on the attached Schedule A, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including,



without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Amended and Restated Security Agreement Collateral");

WHEREAS, the Amended and Restated Security Agreement was recorded in the United States Patent and Trademark Office on October 15, 2001, at Reel 2385 / Frame 0366 (Trademarks);

WHEREAS, pursuant to the Loan Agreement, the Pledgors and Administrative Agent also entered into a Supplement to Amended and Restated Trademark Security Agreement dated as of June 30, 2004 (the "Supplement to the Amended and Restated Trademark Security Agreement"), pursuant to which the Pledgors granted to the Administrative Agent a continuing security interest in all right, title and interest of the Pledgors in, to and under certain of the Trademarks (as defined in the Supplement to the Amended and Restated Trademark Security Agreement,) included among the trademarks listed on the attached Schedule A, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Supplement to the Amended and Restated Trademark Security Agreement Collateral");

WHEREAS, the Supplement to the Amended and Restated Trademark Security Agreement was recorded in the United States Patent and Trademark Office on July 7, 2004, at Reel 3007 / Frame 0412 (Trademarks);

WHEREAS, pursuant to that certain Amended and Restated Loan and Security Agreement (the "2004 Loan Agreement"), dated as of October 19, 2004, the Pledgors granted to the Administrative Agent a security interest in intellectual property as security for loans and other obligations;

WHEREAS, pursuant to the 2004 Loan Agreement, the Pledgors and Administrative Agent entered into a Supplement to Amended and Restated Trademark Security Agreement dated as of October 19, 2004 (the "2004 Supplement to the Amended and Restated Security Agreement"), pursuant to which the Pledgors granted to the Administrative Agent a continuing security interest in all right, title and interest of the Pledgors in, to and under certain of the Trademarks (as defined in the 2004 Supplement to the Amended and Restated Trademark Security Agreement,) included among the trademarks listed on the attached Schedule A, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "2004 Supplement to the Amended and Restated Security Agreement Collateral");

WHEREAS, the 2004 Supplement to the Amended and Restated Security Agreement was recorded in the United States Patent and Trademark Office on October 25, 2004, at Reel 3071 / Frame 0747 (Trademarks);

WHEREAS, pursuant to that certain Third Amended and Restated Credit Agreement (the "Credit Agreement"), dated as of December 8, 2011, the Pledgors granted to the Administrative Agent a security interest in intellectual property as security for loans and other obligations;

WHEREAS, pursuant to the Credit Agreement, the Pledgors and Administrative Agent entered into an Intellectual Property Security Agreement dated as of December 8, 2011 (the "Intellectual Property Security Agreement"), pursuant to which the Pledgors granted to the Administrative Agent a continuing security interest in all right, title and interest of the Pledgors in, to and under certain of the Patents, Trademarks and Copyrights (as defined in the Intellectual Property Security Agreement) included among the trademarks listed on the attached Schedule A, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Intellectual Property Security Agreement Collateral") (the Trademark Security Agreement Collateral, the Amended and Restated Trademark Security Agreement Collateral, the Supplement to the Amended and Restated Trademark Security Agreement Collateral, the 2004 Supplement to the Amended and Restated Trademark Security Agreement Collateral, and the Intellectual Property Security Agreement Collateral, collectively referred to herein as "Trademark Collateral"); and

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on December 9, 2011, at Reel 4675 / Frame 0457 (Trademarks) and on August 14, 2013, at Reel 5091 / Frame 0370 (Trademarks);


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Release. The Administrative Agent hereby, without warranty as to status of title or priority of the encumbrances being hereby released, releases, discharges, terminates and cancels all right, title and interest in, to and under the Trademark Collateral, including, without limitation, any security interest it may have in the Trademark Collateral and the goodwill of the business connected with the use of, and symbolized by, the Trademark Collateral, and retransfers and reassigns any and all right, title, and interest it may have in the foregoing without recourse solely as to the Pledgors.

2. Further Assurances. At the request and expense of the Pledgors, the Administrative Agent hereby agrees to perform all other and further acts, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors to retransfer and reassign any and all right, title and interest it may have in the Trademark Collateral without recourse to the Pledgors.
