**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of September 22, 2017, is made by **ANTARES CAPITAL LP**, as successor to General Electric Capital Corporation, as US/HK Agent (in such capacity, together with its successors and permitted assigns, the “**US/HK Agent**”) for the Lenders (as defined in the Credit Agreement referred to below). Terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement.

**WHEREAS**, in connection with that certain Amended and Restated Credit Agreement, dated as of November 6, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), by and among Daymen U.S., Inc. (“**US Borrower**”), Holdings, the other Credit Parties, the Lenders and the L/C Issuers from time to time party thereto, Antares Capital LP (as successor to General Electric Capital Corporation), as US/HK Agent, Antares Capital LP (as successor to GE Canada Finance Holding Company), as Canadian Agent, and Sumitomo Mitsui Banking Corporation Europe Limited (as successor to GE Corporate Finance Bank SAS, London Branch), as UK Agent, the Lenders and the L/C Issuers have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

**WHEREAS**, pursuant to the Credit Agreement, that certain Pledge and Security Agreement, dated as of October 21, 2010 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Pledge Agreement**”), and those certain agreements described on Annex I attached hereto (collectively with the Pledge Agreement, the “**Security Agreements**”), certain Credit Parties granted, among other collateral as set forth therein, continuing security interests in the intellectual property owned by such Credit Parties (the “**Intellectual Property Collateral**”), including the following:

1. All of the following:
  - a. All of the Trademarks (as defined in the Security Agreements) and all IP Licenses (as defined in the Security Agreements) providing for the grant by or to Grantor (as defined in the Security Agreements) of any right under any Trademark, including without limitation, those referenced in Annex I hereto;
  - b. All renewals and extensions of the foregoing;
  - c. all goodwill of the business connected with the use of, symbolized by, each such Trademark; and
  - d. all income, royalties, proceeds and Liabilities (as defined in the Security Agreements) at any time due or payable or asserted under and with respect to any of the foregoing,, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof; and
2. All of the following:
  - a. all of the Patents (as defined in the Security Agreements) and all IP Licenses providing for the grant by or to such Grantor (as defined in the Security Agreements) of any right under any Patent including, without limitation, those referred to on Annex I hereto;

- b. all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing;
- c. all income, royalties, proceeds and Liabilities (as defined in the Security Agreements) at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof; and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the US/HK Agent hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the US/HK Agent hereby reassigns any and all such right, title and interest (if any) that the US/HK Agent may have in the Intellectual Property Collateral to the Credit Parties. The US/HK Agent agrees, at the expense of the Credit Parties, to cooperate with the Credit Parties and to provide the Credit Parties with the information and additional authorization reasonably required to effect the release of the US/HK Agent's security interests in the Intellectual Property Collateral.
