RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release"), dated as of July 29, 2017, is made by and among MANUFACTURERS AND TRADERS TRUST COMPANY, as lender ("M&T"), and LASERMAX, INC., a Delaware corporation ("Grantor").

WHEREAS, M&T and the Grantor are parties to a Credit Facility Agreement dated June 29, 2012 (as amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Credit Agreement");

WHEREAS, M&T and the Grantor are parties to (i) a Patent Security Agreement dated as of June 29, 2012, recorded with the USPTO at Patent Reel/Frame 030936/0883, (ii) a Patent Security Agreement dated as of June 29, 2012, recorded with the USPTO at Patent Reel/Frame 036669/0829, (iii) a Trademark Security Agreement dated June 29, 2012, recorded with the USPTO at Trademark Reel/Frame 004813/0048, (iv) a Trademark Security Agreement dated June 29, 2012, recorded with the USPTO at Trademark Reel/Frame 005631/0875, (v) a Trademark Security Agreement dated June 29, 2012, recorded with the USPTO at Trademark Reel/Frame 005082/0239 and (vi) a General Security Agreement dated as of June 29, 2012 (together, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, the Grantor pledged to M&T a security interest (referred to in this Release as the "Security Interest") in the Grantor's right, title and interest in, to and under (collectively, the "IP Collateral");

(i) all patents and patent applications (including such patents and patent applications as described in Schedule 1 attached hereto), domestic or foreign, all licenses relating to any of the foregoing, to the extent not prohibited by their terms or applicable law, and all income and royalties with respect to any licenses, all rights to sue for past, present or future infringement thereof, all rights arising therefrom and pertaining thereto and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof;

(ii) all state (including common law), federal and foreign trademarks, service marks and trade names, and applications for registration of such trademarks, service marks and trade names (including, without limitation, such marks, names and applications as described in Schedule 2, but excluding any application to register any trademark, service mark or other mark prior to the filing under applicable law of a verified statement of use (or the equivalent) for such trademark, service mark or other mark to the extent the creation of a security interest therein or the grant of a mortgage thereon would void or invalidate such trademark, service mark or other mark), all licenses relating to any of the foregoing and all income and royalties with respect to any licenses, whether registered or unregistered and wherever registered, all rights to sue for past, present or future infringement or unconsented use thereof, all rights arising therefrom and pertaining thereto and all reissues, extensions, extensions and renewals thereof;

(iii) the entire goodwill of or associated with the businesses now or hereafter conducted by Grantor connected with and symbolized by any of the aforementioned properties and assets;

(iv) all general intangibles and all intangible intellectual or other similar property of Grantor of any kind or nature, associated with or arising out of any of the aforementioned properties and assets and not otherwise described above; and

(v) all proceeds of any and all of the foregoing collateral (including license royalties, rights to payment, accounts receivable and proceeds of infringement suits) and, to the extent not otherwise included, all payments under insurance (whether or not M&T is the loss payee thereof) or any indemnity, warranty or guaranty payable by reason of loss or damage to or otherwise with respect to the foregoing collateral.

WHEREAS, M&T has agreed to terminate and release all of its right, title and interest in or to the IP Collateral, including the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. M&T hereby terminates, extinguishes, cancels, releases and discharges any and all right, title and interest, including the Security Interest, in and to the IP Collateral arising in connection with the Credit Agreement or the Security Agreements and discharges, quit claims and relinquishes unto Grantor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the IP Collateral.


2. Further Assurances. M&T hereby authorizes Grantor or Grantor's authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Security Interest in and to the IP Collateral and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. M&T further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or its agents or designees) reasonably request, at the Grantor's sole cost and expense, in order to confirm this Release and the Grantor's right, title and interest in and to the IP Collateral.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.
