TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of October 16, 2017 (as it may be amended, restated, supplemented or otherwise modified or replaced from time to time, the “**Trademark Security Agreement**”) is made by the grantors listed on the signature pages hereof (the “**Grantors**”) in favor of NexBank, SSB, as administrative agent (in such capacity together with any replacement thereof pursuant to Section 9.07 of the Credit Agreement (as defined herein), the “**Administrative Agent**”).

WHEREAS, the Grantors own the Trademark Collateral (as defined below);

WHEREAS, reference is made to the Debtor-in-Possession Credit Agreement dated as of September 22, 2017 (as modified, amended, supplemented or restated and in effect from time to time, the “**Credit Agreement**”) by and among Toys “R” Us-Delaware, Inc., the Guarantors (as defined therein), the Lenders (as defined therein) and NexBank, SSB, as Administrative Agent and Collateral Agent (as defined therein);

WHEREAS, the Grantors and the Administrative Agent are parties to a Security Agreement dated as of September 22, 2017 (as it may be amended, restated, supplemented or otherwise modified or replaced from time to time, the “**Security Agreement**”) to, among other things, secure the obligations of the Grantors under the Credit Agreement; and

WHEREAS, pursuant to the Security Agreement, each Grantor has granted a security interest in certain property, including, without limitation, certain Intellectual Property of the Grantor to the Administrative Agent and has agreed as a condition thereof to execute this Trademark Security Agreement for recording with the United States Patent and Trademark Office (the “**USPTO**”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Security Agreement.

SECTION 2. Grant of Security. As security for the payment or performance, as the case may be, in full of their respective Secured Obligations, each Grantor hereby grants to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in, to and under such Grantor’s Trademarks, including those set forth on Schedule 1 hereto, including all income, royalties, damages, and payments now or hereafter due and/or payable under any of the

foregoing or with respect to the foregoing, including damages or payments for past, present or future infringements, violations or misappropriations of any of the foregoing, wherever located, whether now owned or hereafter acquired or arising (collectively, the “**Trademark Collateral**”); provided, that any “intent to use” trademark applications for which a statement of use has not been filed with the United States Patent and Trademark Office pursuant to Section 1(c) or 1(d) of the Lanham Act (15 U.S.C. § 1051, et seq.) (but only until a “Statement of Use” or “Amendment to Allege Use” is filed with respect thereto) are excluded from the Trademark Collateral.

SECTION 3. Recordation. This Trademark Security Agreement has been executed and delivered by each Grantor for the purpose of, among other things, recording the grant of security interest herein with the USPTO. Each Grantor hereby authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Trademark Security Agreement.


SECTION 4. Relationship to Security Agreement. The foregoing security interest is granted in conjunction with the security interests granted by each Grantor to the Administrative Agent pursuant to the Security Agreement. Each Grantor acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

SECTION 5. Miscellaneous. This Trademark Security Agreement may be executed in any number of counterparts, each of which were so executed and delivered shall be an original, but all of which shall constitute one and the same instrument. It shall not be necessary in making proof of this Trademark Security Agreement to produce or account for more than one such counterpart. This Trademark Security Agreement and any claim, controversy or dispute arising under or related to this Trademark Security Agreement (including, without limitation, any claims sounding in contract law or tort law arising out of the subject matter hereof) shall be governed by, and construed in accordance with, the law of the State of New York.


