## **ASSIGNMENT OF SECOND LIEN TRADEMARK SECURITY AGREEMENT**

This ASSIGNMENT OF SECOND LIEN TRADEMARK SECURITY AGREEMENT (this “**Assignment**”), dated as of October 17, 2017, is by and between **FIFTH STREET MANAGEMENT LLC (FSML)**”, acting in its capacity as the current and resigning collateral agent (in such capacity, the “**Resigning Agent**”) and **OAKTREE FUND ADMINISTRATION, LLC (“Oaktree”)**, acting in its capacity as the successor collateral agent (in such capacity, the “**Successor Agent**”).

### **RECITALS:**

**WHEREAS**, digicert, Inc., as “Pledgor”, and Resigning Agent are parties to that certain Second Lien Trademark Security Agreement, dated as of October 21, 2015 (as the same has been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the “**Trademark Security Agreement**”), pursuant to which Pledgor granted to Resigning Agent a security interest in all of its right, title and interest in, to and under certain Trademark Collateral (as that term is defined in the Trademark Security Agreement), including the trademarks set forth on Exhibit A attached hereto;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 21, 2015, at Reel/Frame: 5650/0160, and on October 26, 2015, at Reel/Frame: 5652/0805; and

**WHEREAS**, pursuant to that certain Instrument of Resignation and Appointment, dated as of the date hereof, by and among FSML, as Resigning Agent, Oaktree, as Successor Agent, and the other parties thereto, Resigning Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Trademark Security Agreement, in each instance, in its capacity as administrative agent and/or collateral agent, as applicable.s

**NOW, THEREFORE**, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Resigning Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Trademark Security Agreement and the Trademark Collateral.


