## Details

This Deed of Assignment dated 11 day of oct 2017.

Between:

- **SHAUN JONES** of 7 O'Connor Court, Gepps Cross SA 5094, formerly of 13-15 Borduy Place, Mawson Lakes SA 5095, (the Assignor); and
- **SJ ENTERPRISES PTY LTD** of 7 O'Connor Court, Gepps Cross SA 5094 (the Assignee)

Whereas:

- A. The Assignor owns the Intellectual Property, the full details of which are described in the attached **Schedule 1**.
- B. The Assignor wishes to assign the Intellectual Property and all its rights and benefit to the Assignee for a fee of **AUS\$1** and such other consideration which this Agreement may provide.

## Agreed Terms

It is hereby agreed as follows:

  - The Assignor is the sole legal and beneficial owner of all rights, title and interest in the Intellectual Property and is fully entitled to sell, transfer and assign such rights, title and interest as he wishes without requiring the consent of any person.

  - The Assignor hereby sells, assigns and transfers to the Assignee all of its respective rights, title and interest in the Intellectual Property the full details of which are described in the attached Schedule 1.

  - Upon execution of this Agreement, completion of the assignment and payment of the consideration set out above:
    - 3.1 the Assignor relinquishes all rights as defined and provided for under the relevant laws of Australia to the Intellectual Property with the goodwill of the business concerned with the goods associated with the Intellectual Property. The

Assignor acknowledges that the Assignee may subsequently license or assign the Intellectual Property to third parties; and


1. 3.2 the Assignor shall transfer to the Assignee without delay all documents relating to and in support of the ownership and title to the Intellectual Property.


