RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of November 16, 2017, is made by CORTLAND PRODUCTS CORP. (as successor-in-interest to Gleacher Products Corp.), as administrative agent for the Secured Parties (in such capacity and together with any successors and assigns in such capacities, the "Administrative Agent"), in favor of SONIFI SOLUTIONS, INC. (as successor-in-interest to LodgeNet Interactive Corporation) and the other Grantors (each individually a "Grantor", and collectively, the "Grantors") identified in that certain Amended and Restated Guarantee and Collateral Agreement dated as of March 28, 2013 (as may have been further amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") by and among the Grantors and the Administrative Agent.

WITNESSETH

WHEREAS, pursuant to the Collateral Agreement, Grantors executed and delivered to the Administrative Agent that certain Amended and Restated Trademark Security Agreement, dated as of March 28, 2013 (as may have been further amended, restated, supplemented or otherwise modified from time to time, the "*Trademark Security Agreement*"), recorded with the U.S. Patent and Trademark Office on March 29, 2013 at Reel/Frame 4994/0651, in which Grantors pledged and granted to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in all of such Grantor's right, title and interest in, to and under the Trademark Collateral, wherever located, and whether then existing or thereafter arising or acquired from time to time;

WHEREAS, the Grantors request that the Administrative Agent release, discharge, terminate and cancel its security interest in and to the Trademark Collateral, including but not limited to the trademark registrations and applications listed on Schedule I attached hereto, together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof (the "*Trademarks*");

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent, without recourse, representation or warranty of any kind or nature, and at the Grantors' sole cost and expense, hereby releases, discharges, terminates and cancels its remaining security interest in and to the Trademark Collateral, including but not limited to the Trademarks.

The Administrative Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of New York.

Capitalized terms used but not defined herein shall have the meanings given to them in the Collateral Agreement or the Trademark Security Agreement.
