## **TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of November 2, 2017, by NXT CAPITAL, LLC in its capacity as Agent for the Lenders party to the Credit Agreement (“Grantee”) in favor of the Grantors (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

### WITNESSETH:

WHEREAS, Foundation Consumer Healthcare, LLC, a Delaware limited liability company (“FCH”), Theravent, Inc., a Delaware corporation (“Theravent”; Theravent, together with FCH, each a “Grantor” and collectively, “Grantors”) and Grantee were parties to that certain Trademark Security Agreement made as of March 30, 2017 (the “Security Agreement”) pursuant to which the Grantors granted a security interest to Grantee in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantors to Grantee, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 30, 2017, at Reel 6024, Frame 0678; and

WHEREAS, each Grantor has requested that Grantee release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to each Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantee agrees as follows:

1. Grantee hereby releases, terminates and discharges fully its continuing security interest in all of each Grantor’s right, title and interest in and to the following, and authorizes the recordation of this Release with the United States Patent and Trademark Office (collectively the “Trademark Collateral”):

- (i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (ii) all products and proceeds of the forgoing, including without limitation, any claim by Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any such Trademark.

2. Grantee hereby reassigns, grants and conveys to the Grantors, without any representation, recourse or undertaking by Grantee, any and all of Grantee’s right, title and interest in and to the Trademarks and the Trademark Collateral, and authorizes the recordation of this Release with the United States Patent and Trademark Office.
