# TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

- (b) if and to the extent MassDevelopmenthas acquired any right, title or interest in, to or under anyassets of the Grantor, or Proceeds of the foregoing, assigns, transfers, conveys and delivers such right, title or interest to the Grantor:
- (c) agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, in each case at the Grantor's sole expense; and
- (d) authorizes and request that the Commissioner for Patents in the USPTO, and any other necessary United States government officer, record this Release; it being understood that such recordation shall be at the Grantor's sole expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts.
