#### RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is given as of October 19, 2017 to LANDAUER, INC., a Delaware corporation (the "Grantor") by BMO HARRIS BANK N.A., as Administrative Agent, for the benefit of itself, its successors and assigns, the Lenders, as defined below (in such capacity, the "Administrative Agent"), with respect to the Trademark Collateral (as defined in the Security Agreement and the Trademark Security Agreement), including, without limitation, each of the trademarks identified on Exhibit A to this Release (the "Released Trademarks").

WHEREAS, the Grantor, the other Parties party thereto, the Administrative Agent, as administrative agent for the Lenders party thereto (the "Lenders") entered into that Second Amended and Restated Credit Agreement dated as of July 13, 2017 (the "Credit Agreement"), unless otherwise defined herein, terms not defined herein shall have the meaning given to such terms in the Credit Agreement;

WHEREAS, the Grantor and Administrative Agent entered into that Second Amended and Restated Guaranty and Security Agreement, dated as of July 13, 2017 (the "Security Agreement"), pursuant thereto, the Grantor has granted in favor of the Administrative Agent that certain (i) Trademark Security Agreement dated November 14, 2011, which was recorded in the United States Patent and Trademark Office at Reel/Frame 004669/0740 and (ii) Trademark Security Agreement (Supplemental) dated July 13, 2017, which was recorded in the United States Patent and Trademark Office at Reel/Frame 006105/0926 (collectively, the "Trademark Security Agreement"); and

WHEREAS, Administrative Agent desires to release its security interest in and liens upon the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby states as follows:

- 1. Release. Administrative Agent, on behalf of itself and the Lenders hereby (i) terminates, releases, and discharges its Lien on and security interest in the Trademark Collateral, (ii) waives and relinquishes all its rights, powers, privileges and remedies with respect to the Trademark Collateral (iii) reassigns, grants, and conveys to the Grantor any and all right, title and interest it may have in the Trademark Collateral, together with the goodwill of the business symbolized thereby, and (iv) terminates the Trademark Security Agreement.
- 2. <u>Recordation of Trademark Release</u>. This Release has been executed and delivered by the Administrative Agent for the purpose of recording with the United States Patent and Trademark Office.
- 3. <u>Governing Law</u>. This Release shall be construed in accordance with the laws of the State of Illinois without giving effect to any conflict of law principles (but giving effect to laws relating to national banks).
