## RELEASE OF JUNIOR SECOND LIEN TRADEMARK SECURITY INTEREST

THIS RELEASE dated as of February 1, 2017 (this "Release") is made by NAG, LLC (f/k/a CENTRIC GROUP, L.L.C.), acting in its capacity as administrative agent (in such capacity, the "Agent") under that certain Pledge and Security Agreement, dated as of October 14, 2016, and that certain Second Lien Loan Agreement, dated as of October 14, 2016, in each case, among TKC Holdings, Inc., a Delaware Corporation, TKC Intermediate Holdings, LLC, a Delaware limited liability company, and other parties thereto (as amended, supplemented or modified and in effect from time to time, collectively, the "Security and Loan Agreements") and that certain Junior Second Lien Trademark Short Form Security Agreement, dated as of October 14, 2016 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among Keefe Group, LLC, a Missouri limited liability company, Advanced Technologies Group, L.L.C., a Missouri limited liability company, Courtesy Products, L.L.C., a Missouri limited liability company, Inmate Calling Solutions, L.L.C., a California limited liability company, Courtesy Group, L.L.C., a Missouri limited liability company, Swanson Services Corporation, a Florida corporation and Cobra Software Group, L.L.C., a Florida limited liability company (collectively, the "Grantors" and each a "Grantor") and the Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on October 14, 2016 at reel 5900, frame 0883, the Grantors granted to the Agent a continuing security interest in all of Grantors' right, title and interest in or to the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademark registrations and applications set forth on Schedule A attached hereto.


WHEREAS, Grantors have requested and Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of all of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent does hereby, on behalf of itself and any lender for which it acts as Agent, (a) terminate the liens and security interest created under the Security and Loan Agreements and the Trademark Security Agreement in and to the Trademark Collateral, (b) release its security interest in and to the Trademark Collateral, (c) discharge and relinquish any and all rights, title and interest it has in and the security interest granted to Agent in the Trademark Collateral, and (d) re-assigns to each applicable Grantor any right, title and interest the Agent may have in, to or under the Trademark Collateral of such Grantor.


