("RSI"), a California corporation and Acrisure of California, LLC ("AoC"), a California limited liability company (collectively, the "Grantors", and each individually, a "Grantor").

WHEREAS, pursuant to the Security Agreement, each Grantor granted to the Administrative Agent for the benefit of the Secured Parties a security interest in all of such Grantor's right, title, interest in and to the Collateral, including the registered and applied-for Trademarks of each Grantor, including the trademarks set forth on the attached Schedule I, and all goodwill connected with the use of and symbolized thereby (collectively, the "Trademark Collateral");
