ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION
OF
LIFE'S MISSING LINK

I, the undersigned Deborah Renshaw, Executive Director of Life's Missing Link (the "Company"), a corporation subject to the provisions of Chapter 317A, Minnesota Statutes, known as the Minnesota Nonprofit Corporation Act, do hereby certify that pursuant to a meeting of the Board of Directors of the Company on August 31, 2006, the following resolutions were adopted:

RESOLVED, that Article I of the Corporation's Articles of Incorporation be and hereby is amended and replaced in its entirety with the following:

"ARTICLE I
NAME

FURTHER RESOLVED, that any officer or legal counsel of the Company is authorized and directed to file with the office of the Minnesota Secretary of State an amendment to the Articles of Incorporation of the Company as set forth above.
