WHEREAS, Grantor has requested that the Agent release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Released Registered Trademarks; and

WHEREAS, the Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Released Registered Trademarks, and reassign any all rights, title and interest in the same to Grantor.




The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.


