TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT**, dated as of November 21, 2017 (as amended, restated, supplemented or otherwise modified from time to time, this “**Trademark Security Agreement**”), is made by AVANTOR PERFORMANCE MATERIALS, LLC, a New Jersey Limited Liability Company with an address at 1050 Cindy Lane, Carpinteria, CA 93013, NUSIL TECHNOLOGY, LLC, a Delaware Limited Liability Company with an address at 3477 Corporate Parkway, Center Valley, PA 18034, TRELYST LLC, a Delaware Limited Liability Company with an address at 1050 Cindy Lane, Carpinteria, CA 93013, PURITAN PRODUCTS, INC., a Pennsylvania Corporation with an address at 1050 Cindy Lane, Carpinteria, CA 93013, AMRESKO, LLC, an Ohio Limited Liability Company with an address at 6681 Cochran Road, Solon, OH 44139, VWR INTERNATIONAL, LLC, a Delaware Limited Liability Company with an address at Radnor Corporate Center, Building One, Suite 200, 100 Matsonford Road, Radnor, PA 19087, INTEGRA COMPANIES, LLC, a Massachusetts Limited Liability Company with an address at 29 Saratoga Boulevard, Devens, MA 01434, THERAPAK, LLC, a California Limited Liability Company with an address at 651 Wharton Drive, Claremont, CA 91711, EPL PATHOLOGY ARCHIVES, LLC, a Virginia Limited Liability Company with an address at 45610 Terminal Drive, Sterling, VA 20166, TEK PRODUCTS, LLC, a Minnesota Limited Liability Company with an address at 2435 Industrial Blvd., Long Lake, MN 5535-0547, and RELIABLE BIOPHARMACEUTICAL, LLC, a Delaware Limited Liability Company with an address at 1945 Walton Road, Overland, MO 63114 (each, a “**Grantor**”, and collectively, the “**Grantors**”) in favor of THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., as Notes Collateral Agent for the Secured Parties (in such capacity and together with its successors and permitted assigns in such capacity, the “**Notes Collateral Agent**”).

WHEREAS, each Grantor is party to that certain Security Agreement, dated as of November 21, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), among such Grantor, the other grantors party thereto and the Notes Collateral Agent pursuant to which such Grantor granted a security interest to the Notes Collateral Agent in the Trademark Collateral (as defined below) and is required to execute and deliver this Trademark Security Agreement.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each Grantor hereby agrees with the Notes Collateral Agent as follows:

SECTION 1. DEFINED TERMS

Unless otherwise defined herein, capitalized terms have the meaning given to them in the Security Agreement.

SECTION 2. GRANT OF SECURITY INTEREST

Each Grantor, as security for the payment and performance in full of the Secured Obligations of such Grantor (including, if such Grantor is a Guarantor, the Secured Obligations of such Grantor arising under the Guaranty), hereby pledges to the Notes Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in and to any and all Trademarks now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest, including, without limitation, those identified in Schedule A hereto (collectively, the “**Trademark Collateral**”), *provided* that the Trademark Collateral shall not include any Excluded Assets.

SECTION 2.1 CERTAIN LIMITED EXCLUSIONS.

Notwithstanding anything herein to the contrary, in no event shall the Trademark Collateral include or the security interest granted under Section 2 hereof attach to any “intent-to-use” trademark application prior to the filing and acceptance of a “Statement of Use” or “Amendment to Allege Use” with respect thereto, to the extent, if any, that, and solely during the period, if any, in which the grant of a security interest therein would impair the validity or enforceability of, or void, such “intent-to-use” trademark application, or any registration that may issue therefrom, under applicable federal law.

SECTION 3. SECURITY AGREEMENT

The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Notes Collateral Agent for the Secured Parties pursuant to the Security Agreement, and each Grantor hereby acknowledges and affirms that the rights and remedies of the Notes Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. RECORDATION

Each Grantor hereby authorizes and requests that the USPTO record this Trademark Security Agreement.

SECTION 5. TERMINATION

This Trademark Security Agreement shall terminate and the lien on and security interest in the Trademark Collateral shall be released upon the payment and performance of the Secured Obligations in accordance with the Notes Documents. Upon the termination of this Trademark Security Agreement, the Notes Collateral Agent shall execute all documents and take all other actions reasonably requested by each Grantor, and at such Grantor’s sole cost and expense, to evidence the release of the lien on and security interests in the Trademark Collateral granted herein; *provided* that in no event shall the Notes Collateral Agent have any obligation to file or record any documents or instruments in any public office at any time or times.

SECTION 6. GOVERNING LAW

THIS TRADEMARK SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

SECTION 7. COUNTERPARTS

This Trademark Security Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

SECTION 8. CONCERNING THE NOTES COLLATERAL AGENT

For the avoidance of doubt, the parties hereto agree that the Notes Collateral Agent shall be afforded all of the rights, protections, indemnities, immunities and privileges afforded to the Notes

Collateral Agent under the Indenture and the Security Agreement in connection with its execution of this Trademark Security Agreement and the performance of its obligations hereunder. The recitals contained herein shall be taken as the statements of the Grantors and the Notes Collateral Agent assumes no responsibility for their correctness. The Notes Collateral Agent makes no representations as to the validity or sufficiency of this Trademark Security Agreement.
