WHEREAS, pursuant to the Security Agreements, which were recorded with the U.S. Patent and Trademark Office on January 13, 2017 at Reel 5966 / Frame 0592 and at Reel 041041 / Frame 0642, and the Reaffirmation and Amendment of IP Security Agreement recorded on January 25, 2017 at Reel 5974 / Frame 0643, the Grantors granted the Agent a security interest and lien in and to (i) the Marks, Patents and Copyrights (as such terms are defined in the Security Agreements), including the Marks listed in Schedule I hereto, Patents listed in Schedule II hereto, and (ii) the goodwill associated with the Marks, all licenses for any of the foregoing, and all causes of action arising prior to or after the date thereof for infringement, dilution, misappropriation, violation and unfair competition of or regarding the same (collectively (i) and (ii), the "Collateral");

WHEREAS, the credit facilities referred to in the Security Agreements have been terminated and the Grantors have requested that the Agent enter into this Release in connection with the termination of the Security Agreements.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby (i) releases, without representation, warranty or recourse, all of its and their security interests and liens in and to the Collateral, including without limitation the Collateral listed on Schedule I attached hereto and incorporated herein by reference, (ii) terminates the Security Agreements, and (iii) if and to the extent the Agent has acquired any right, title or interest in, to or under the Collateral, re-assigns to Grantors any right, title and interest it or they have in, to and under the Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
