### RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of December 1, 2017 is made by Healthcare Financial Solutions, LLC, in its capacity as administrative agent (as successor-in-interest to General Electric Capital Corporation, "Administrative Agent"), under the Security Agreement (as defined below) and Trademark Security Agreements (as defined below), in favor of each of CryoLife, Inc., a Florida corporation, Cardiogenesis Corporation, a Florida corporation, On-X Life Technologies, Inc., a Delaware corporation, and Valve Special Purpose Co., LLC, a Delaware limited liability company (each, a "Grantor"), and collectively, the "Grantors").

WHEREAS, General Electric Capital Corporation and the Grantors are parties to that certain Guaranty and Security Agreement, dated as of March 27, 2008 (the "Security Agreement"), whereby the Grantors granted to General Electric Capital Corporation a security interest in and to the Grantors' Trademark Collateral.

WHEREAS, pursuant to the Security Agreement, General Electric Capital Corporation and the Grantors are parties to the following Trademark Security Agreements (collectively, the "<u>Trademark Security Agreements</u>"):

- 1) Trademark Security Agreement dated as of March 27, 2008 and duly recorded on March 31, 2008 in the United States Patent and Trademark Office at Reel 3749, Frame 0477;
- 2) Trademark Security Agreement dated as of October 30, 2010 and duly recorded on November 3, 2010 in the United States Patent and Trademark Office at Reel 4309, Frame 0430;
- 3) Trademark Security Agreement dated as of November 22, 2010 and duly recorded on December 8, 2010 in the United States Patent and Trademark Office at Reel 4428, Frame 0079;
- 4) Trademark Security Agreement dated as of June 30, 2011 and duly recorded on July 4, 2011 in the United States Patent and Trademark Office at Reel 4574 and Frame 0988;
- 5) Trademark Security Agreement dated as of September 26, 2014 and duly recorded on September 29, 2014 in the United States Patent and Trademark Office at Reel 5370, Frame 0007;
- 6) Trademark Security Agreement dated as of February 9, 2015 and duly recorded on February 12, 2015 in the United States Patent and Trademark Office at Reel 5458, Frame 0842; and
- 7) Trademark Security Agreement dated as of January 20, 2016 and duly recorded on January 21, 2016 in the United States Patent and Trademark Office at Reel 5713, Frame 0619; and

WHEREAS, the Grantors have paid in full and satisfied the Secured Obligations, and Administrative Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantors and to dissolve any and all liens and encumbrances respecting the Trademark Collateral, including, but not limited to, the trademark registrations and applications set forth in Exhibit A attached hereto (collectively with the Trademark Collateral, the "Released Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

- 1. <u>Defined Terms</u>. Capitalized terms used herein without definition are used as defined in the Security Agreement or Trademark Security Agreements, as applicable.
- 2. <u>Release</u>. Administrative Agent hereby releases, discharges, quit claims and relinquishes unto the Grantors the security interest in the Released Trademarks granted to Administrative Agent by the Grantors pursuant to the Security Agreement and Trademark Security Agreements. Administrative Agent hereby assigns, transfers and delivers to the Grantors all of its right, title and interest in and to the Released Trademarks. Administrative Agent acknowledges and agrees that, as a result of this Release, it has no further rights to or interest in the Released Trademarks.
- 3. <u>Further Assurances</u>. Administrative Agent hereby agrees, at the Grantors' expense, to execute such instruments and to take such other actions as the Grantors may reasonably request to terminate Administrative Agent's security interest in the Released Trademarks, and otherwise to effectuate the release of the Released Trademarks from Administrative Agent's security interest.
- 4. <u>Recordation</u>. Administrative Agent hereby authorizes and requests the governing body of the United States Patent and Trademark Office to record this Release.
