MEMORANDUM OF TRADEMARK ASSIGNMENT

This **MEMORANDUM OF TRADEMARK ASSIGNMENT** is by and between EZetil GmbH (formerly named ZOG-Zorn Outdoor Germany GmbH), a limited liability company organized under the laws of Germany, with a business address of EZetilstrasse 1, DE-35410 Hungen-Inheiden, Germany ("Assignor") and Dometic Sweden AB, a limited liability company organized under the laws of Sweden, with a business address of Hemvärmsgatan 15, SE-171 54, Solna, Sweden ("Assignee"). For purposes of this Memorandum of Assignment, Assignor and Assignee are each referred to individually as a "Party", and together as the "Parties."

WHEREAS, as of January 4, 2017, Assignor was the owner of all right, title and interest in and to the trademark EZETIL (the "Mark") and the corresponding registration issued by the United States Patent & Trademark Office ("USPTO"), namely, Reg. No. 2,679,516 (the "Registration").

WHEREAS, pursuant the Assignment and Transfer of Intellectual Property Rights executed by and between the Parties dated March 27, 2017 (the "Assignment"), Assignor transferred all of its right, title and interest in and to the Mark and Registration to Assignee, together with the goodwill of the business symbolized by the Mark and Registration, and all claims and rights associated therewith, including but not limited to the right to bring and maintain all actions for past, present and future infringements and rights of priority and protection of interests therein under the laws of any jurisdiction worldwide based on the Mark, all effective as of January 4, 2017.

WHEREAS, pursuant to the terms of the Assignment, Assignor agreed to execute such other documents as may be required for the purpose of recording the Assignment and Assignee as owner of the Mark and Registration.

WHEREAS, the Parties now wish to memorialize Assignee's acquisition of all right, title and interest in and to the Mark and Registration from Assignor in accordance with the Memorandum of Trademark Assignment herein.

NOW THEREFORE, in consideration of the execution of the Assignment, the payment of the consideration provided therein, and other good and valuable consideration, the receipt and sufficiency of which are herein acknowledged, EZetil GmbH does hereby memorialize its assignment of said Mark and Registration to Dometic Sweden AB pursuant to the Assignment and effective as of January 4, 2017.
